St JAMES'S, Dec. 28.

This day the Count de Woronzow had a private audience of his Majesty, to notify the death of the late Empress of Russia, and the accession of the present Emperor, Paul the First, to the throne of Russia; and to deliver his new credentials as Envoy Extraordinary and Minister Plenipotentiary from the Emperor of Russia. To which he was introduced by the Right Hon. Lord Grenville, his Majesty's Principal Secretary of State for Foreign Affairs, and conducted by Sir Stephen Cottrell, Knt. Master of the Ceremonies.

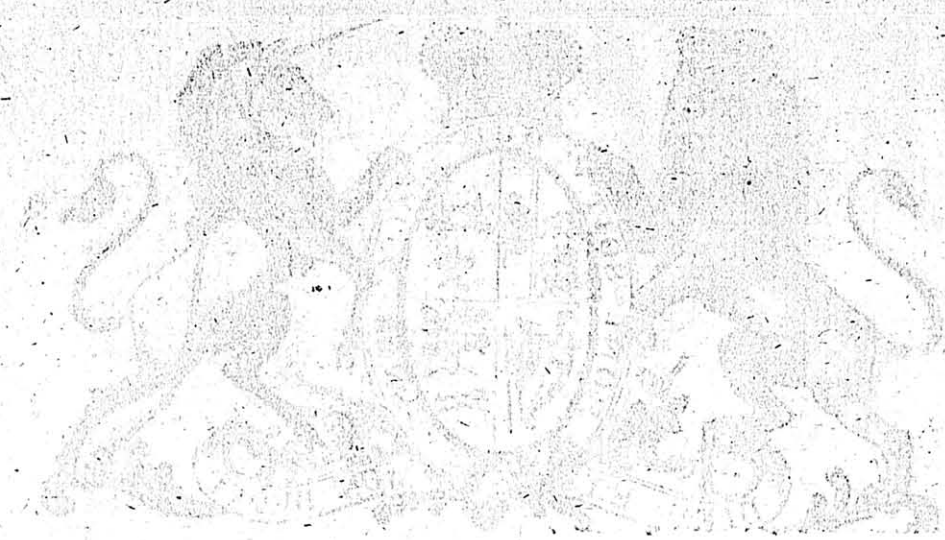
