Constantinople, August 8.

The Rlague, which had encreafed to an alarming. Degree about a Fortnight ago, is at prefent greatly diminifhed. This favourable Change is probably owing to the warm Weather which has prevailed here fince Eight or Ten Days. The last Letters from -Smirna advise the total Ceffation of the Plague in - that City, and it's Neighbourhood, which continued free from every Appearance of Diforder.

Naples, August 24.

On Thurfday Night last his Sicilian Majesty set out from Naples for Barletta. The Queen, in Company with the newly married Princeffes, left this City the next Evening, and arrived at Barletta in Twenty-one Hours, not having flopped on the Road. Immediately after the Queen's Arrival his Sicilian. Majesty embarked on Board of one of his Frigates, and the Quren and Princeffes on Board of another, and fet Sail with a favorable Wind for Fiume.

Stockholm, August 31.

The King of Sweden arrived at his Country-· Seat of Haga, in the Neighbourhood of this City, the 26th Inftant; and Yeiterday made his publick Entry into Stockhelm, on Horfeback, amidft the Acclamations of a great Conccurfe of People, who had affembled in the Streets through which he was to pass. His Majesty was accompanied by such of the Officers who have diffinguished themselves during the late Campaign, as were already arrived from

- Finland, and was eleorted by the City Guards, who have performed the Military Service of the Capital fince the Commencement of Hoftilities against Ruffia.

His Majefty first went to the Cathedral Church ; and, after having performed his Devotions there, repaired to the Town-Hall, where he, in a very gracions Speech, thanked the Burgeffes affembled for the Marks of Loyalty and Attachment he has received from them during the War. In the Even-ing there was a Drawing-Room, where the Foreign : Minifiers had an Opportunity of paying their Court to his Majefty.

To-day Peace was proclaimed with the ufual So-lemnities in the different Quarters of the City. : The Royal Family, the Nobility, and other Perfons of Diffinction, affifted at the Te Deum, which was fung with great Pomp at the Cathedral; after which there was a Court and Public Dinner at the Palace; and the Evening is to clofe with Illuminations and other Demonstrations of Joy.
