A^T the Court at St. James's, the 13th of November, 1793,

PRESENT,

The KING's Most Excellent Majesty in Council. 7 HEREAS it is highly important that fpecial Precautions should be taken to prevent any Kind of Corn, Meal or Flour, of which the Exportation from this Kingdom may be permitted, from falling into the Hands of the Enemy, and being made Ufe of for the Support and Suftenance of the Forces employed by Sea and Land against His Majesty or His Allies; His Majefty, having taken the fame into Confideration, is pleafed, by and with the Advice of His Privy Council, to order, as it is hereby ordered, that no Ship or Veffel, laden with any Sort of Corn, Meal or Flour, which fhall be exportable purfuant to the Provisions of an Act, passed in the Thirty-first Year of His prefent Majefty's Reign, intituled, " An " Act for regulating the Importation and Exportast tion of Corn, and the Payment of the Duty on " Foreign Corn imported, and of the Bounty on " British Corn exported," and of an Act passed in the laft Seffion of Parliament for amending the faid Act, shall be permitted to clear out from any Port of this Kingdom, until the Merchant Exporter of fach Corn, Meal or Flour, shall have made Oath of the true Defination of the fame to the Places for which fuch Corn, Meal or Flour shall be entered Outwards, before the Entry shall be made, and shall alfo, together with Two fufficient Sureties, of which the Master of such Ship or Vessel shall be One, have entered into Bond, in treble the Value of fuch Corn, Meal or Flour, with Condition to carry the fame to His Majefty's Kingdom of Ireland, or to the Iflands

of Guernfey, Jerfey, Alderney, Sark or Man, or to fome Country, in or out of Europe, in Amity with His Majefty, or to fome of His Majefty's Colonies or Plantations in America or the West Indies, or to the Ifland of Newfoundland, or to fome Fort or Garrifon belonging to or under the Protection of His Majefty, or to His Majefty's Settlements on the Coaft of Africa, or to the Island of St. Helena, or to the British Settlements or Factories in the East Indies; and that fuch Ship or Vefiel shall not depart from the Coaft, or proceed on her Voyage, without Convoy, and not defert fuch Convoy until fuch Ship or Veffel fhall arrive at the Place of her Defination, or as long as fuch Convoy shall be instructed to protect the faid Ship or Veffel. And fuch Bond shall be difcharged by a Certificate, in like Manner as is directed with refpect to Bonds entered into for the due Exportation of Corn and other Articles exported on Bounty, in purfuance of the before mentioned Act, passed in the Thirty-first Year of His prefent Majesty's Reign; and fuch Bond shall not be cancelled or delivered up but upon Production of fuch Certificate.

Provided always, that fuch Bond fhall not be required with respect to any Ship or Vesiel having on beard no greater Quantity of any Corn, Meal or Flour, than shall be necessfary to be carried in such Ship or Vessel on her Voyage, Out and Home, for the Sustemance, Diet, Support, and Use of the Commander, Master, Mariners, Passens and others, or of the Cattle, Live Stock, or other Animals on board of such Ship or Vessel.

Provided also, that fo much of the Condition of the faid Bond as relates to not departing without Convoy, or deferting fuch Convoy, shall not be required

THE Difpatch, of which the following is an Extract, was this Morning received at the Office of the Right Honorable Henry Dundas, His Majeity's Principal Secretary of State for the Home Departinent.

SIR,

Toulon, October 3, 1793.

IN my Difpatch of the 24th of September I had the Honor to inform you, that the Enemy had been more active than previous to that Period; they occafionally cannonaded our different Pofts, and had approached Bodies of Men to various Points, to at-tract our Attention. On the 30th of September, at Night, they entered upon a daring and defperate Project, that met with a most unaccountable Success,

which fortunately was not of long Duration. The Poft of Faron being the Point at which the Enemy determined to make an Attempt to render themfelves Mafters of Toulon, they carried their Dcfign into Execution on the Night of the 30th of Sep-tember. The Piquet of Sixty Men, being driven from the Pas de la Masque about Day-break, rctired to the Redoubt of Faron, which they found abandoned by the Spanish Garrison that had been placed The Enemy fome Time after took Postellion in it. of the Redoubt, and of the whole Summit of this almost inaccessible Mountain. By the Possession of the Redoubt of Faron their Communication was open with La Valette, and with La Garde, where the Head Quarters of General Gardane are established;

from both which Places they received confiderable Reinforcements. The Fort of Faron, which is below the Redoubt, having made the Signal of being preffed by the Enemy, and in Want of immediate Succour, Governor Elphinstone added Captain Torriano, with Ninety-two Men of the 30th Regiment, to the Garrifon of that Poft.

At about Seven o'Clock in the Morning of the ift of October, the Report came to Toulon, that the Enemy were in Poffeffion of the whole Summi: of the Mountain of Faron. The abfolute Necessity of an immediate Attack of this Poll being obvious, the most practicable Means of regaining the Summit of the Mountain, in the Face of an Enemy, who were hourly receiving Reinforcements, and who were prepared for their Defence, became the only Subject of Difcuffion. Admiral Gravina, Brigadier-General Discussion. Admiral Gravina, Brigadier-General Squierdo of the Spanish Troops, Brigadier-General Prince de Pignatelli commanding the Neapolitan Troops, Lieutenant-Colonel Chevalier de Revel, Governors Goodall, Elphinstone and myself; having affembled at the Government Houle, and having confulted intelligent Perfons acquainted with the poffible Accesses to the Mountain on the Side of Toulon, it was determined to make the Attempt on the Western Side. The Troops of the Garrison having been affembled on the Parade during the Time of our Deliberation, I detached Captain Beresford of the 60th Regiment, with Fifty Men, to Fort Faron, to co-operate under the Command of Governor Elphinitone, in cafe any Opportunity fhould offer of making a Diversion on the Side of the Redoubt of Faron, in Favour of our main Attack, if we should be fo fortunate as to reach the Summit of the Moun-

tain, which is 1718 Feet above the Level of the Sea. The British Troops upon Guard at the Gate of the Town having been relieved, I was enabled to collect 250 British Rank and File, to which I added 140 Chasfleurs and 163 Grenadiers of the Piedmontese Troops, (the Remainder being difperfed in diffant Pofts.) This Corps composed the Column under my Command, deftined to afcend the Face of the Mountain from the Fort of Grand St. Antoine. (I had alfo ordered 500 Neapolitan Troops of the Regiment de Bourgogne to join my Column; but, from the Difference of Language, fome Miftake occurred in the Delivery of the Orders, and those Troops did The Column of Admiral Gravina, not join me:) which took it's Route towards the Vallon de Valbourdin to afcend by that Pafs, was composed of Two Companies of Piedmontele Chasfleurs, 183 S, anish Rank and File, 400 Ncapolitán Grenadiers, and a Detachment of 100 Men of the Regiment de Bourgogne; Brigadier-Generals Squierdo and Pig-natelli went with this Column. The Two Columns marched from Toulon at Eight o'Clock. At the Redoubt of Grand St. Antoine I formed the Troops under my immediate Command in alternate Hundreds of British and Piedmontese, directing?them to keep in small Platoons, as nearly in a Line as poffible during their Afcent, and to form to the first Party that should arrive at the Summit. An advanced Party of 200 of the Enemy appeared at the Top of the Mountain, and gave their Fire at a great Distance, retiring im -mediately, and allowing the Troops to gain the Height with no other Obstacle than that which the rugged and almost perpendicular Acclivity prefented; the Labour and Fatigue of the Ascent being confiderably increased by the great Heat of the Day. The Column of General Gravina gained the Top of the Mountain foon after us, without having met with any Refutance. Captain Moncrief, who led the Right Division of my Column, pushed across the Mountain, and possessible himfelf of the Pas de la Masque, which had

and been abandoned by the Eremy. The Top of the Mountain of Faron is interfected by a Succeifion of transverfal Heights, of fleep Afcent from the Weft, and rifing fucceffively to the Eafternmoft Extremity of the Mountain, where the Redoubt of Faron is pluced. We found the Enemy drawn up on the Front of this laft Ridge. The Rock to the North, on the Right of the Position taken by the Enemy, ends in a Precipice above the Vallon de Favieres; the Ground which lay between the Right of the Enemy and the Column under my Command is a low Ridge, forming the narrow Head of a deep Valley, which defeends to the South ward, widening itelf by a gradual Turn to the Eastward, fo as to form a freep Side to the Left Flank of the Enemy's Position, and ending on the flat Summit of an interior Ridge of the Mountain, directly above the Town of Toulon.

The Enemy were formed in a Line on the Front of the Eminence, and within Musket Shot of our Pofition: In Front of the Right of the Enemy's principal Line, and on the Creft of the Ridge which forms the Head of the Valley, they had an Advanced Guard of about Fifty Men; in the Rear of their Right Flank, which did not reach up to the Precipize, a Body of about 200 Men were placed en Echellon ; a confiderable Body was placed en Potence behind the Left of their Line; and in Front of their Left Flank was placed an Advanced Guard, fimilar to that on the Right; in the Rear, half Way between the Redoubt and the first Line, a strong Column was placed in Referve; and the Parapet of the Redoubt was lined with Men. The Polt of the Enemy com-manded very confiderably every Part of the Polition which we were obliged to occupy. The Left Column, under my Command, arrived first in Prefence of the Enemy. I placed the greatest Part of it, under Cover of a rifing Ground, behind the narrow Creft of the Valley over which I was to pass, when the Attack should be made. The Column of General Gravina heing foon after also in Prefence of the Enemy, he formed his Line on an Height, which extended beyond the Left of the Enemy's Polition, and was feparated from the Height on which I had taken Post by a Branch of the great Valley, running to the Weftward, and forming a Dip between the Posts occupied by our respective Divisions. I immediately fent Notice of our being in Prefence of the Enemy (by an Officer, who was obliged to make a confiderable Circuit) to Governor Elphinftone, who was at Fort Faron.

A brifk Fire, begun by the Advanced Pofts of the Enemy, took Place at this Time between them and General Gravina's Line, and a Fire alfo commenced on the Side of Fort Faron by the Corps under the Command of Colonel del Porto, against the Potence (or Return Line) of the Enemy's Polition, which could not, however, at that Time, produce it's Ef-fect, and was foon after very judicioufly difcontinued. As I could plainly perceive from the Post I occu-pied that no Impression could be made from a Fire across the deep Part of the Valley, and that there was a Defect in the Disposition of the Enemy's Left, I went to the Right, to communicate my Obfervations to General Gravina; and it was then agreed that the Corps under the Command of that General should defcend, by it's Right, into the Valley, and march, under Cover of the Afcent on the Left of the Enemy, to attack them on that Flank, which they had injudicioufly placed upon the extreme Summit of the Hill, fo as not to have the Command of the whole Defcent, as they might have had, by placing themfelves a little below the Brow. It was agreed alfo, that the Left Column, under my Com-

mand, should endeavour to attract the Attention of the Enemy during this Movement, and that when General Gravina should have attained a certain Point, I should move forward, and the general A tack be made. On my Return to the Left (General Gravina having already began his Movements) I produced my whole Force to the View of the Enemy. The Operation answered to our utmost Wish. The Enemy matched Reinforcements to the Right of their Line, and appeared in Expectation of an immediate Attack from my Column : During this Period Ge-neral Gravina proceeded down the Valley, and came unperceived up the Side of the Hill occupied by the Enemy; the Line of March round this ficep and rocky Afcent being explored, with infinite Intrepidity and Judgment, by Serjeant Moreno of the Spanish Marines, and Three Soldiers of his Corps, to within Pitol Shot of the Enemy's Line. The whole Creft of the Mountain of Faron being a hard grey Rock, without Vegetation, and in forme Parts broken into fharp and loofe Pieces, which render walking very difficult, the March of General Gravina's Column was neceffarily flow : As foon as he had got to the Point agreed upon, the British of my Column, led by Captain Moncrief of the 11th Regiment, and preceded by Thoinas Graham, Efq; of Balgeroon, (a Gentleman of independent Fortune, who was attracted to Toulon by the extraordinary Event of it's being in our Possession, to whose Abilities on many Occasions here, and to whose diffinguished and exemplary Gallantry on this Occasion the Service has been infinitely indebted) and the Piedmontefe Chaffeurs, led by Lieutenant-Colonel the Chevalier de Revel, advanced in Two Columns, fupported by the Piedmontese Grenadiers, under Colonel the Comte de Forax, the Ridge being too narrow to admit of a Line. A very heavy Fire from the greatest Part of the Enemy's Line checked our Progress for a short Period at somewhat less than Half the Way, between the Ground from which we had advanced and the Enemy's Post. Here a continued Fire was kept up between the Enemy and the British and Piedmontefe Troops, under every Difadvantage on our Part of a most exposed and confined Situation. The Column of General Gravina in the mean Time advanced in excellent Order, under Cover of the Hill ; the Two Companies of Piedmontese Chasseurs, with the Neapolitan Grenadiers and Spanish Troops, advancing with a regular Progress, and well-fupported Fire, towards the Left of the Enemy's Line, whilft the Detachment from Fort Faron, under Colonel • Comte del Porto, recommenced their Attack, which they made a real one, inftead of a mere Diversion, as at first intended. At this Inftant the Diversion, as at first intended. At this Instant the advanced Part of General Gravina's Column having nearly gained the Brow of the Hill, I perceived the Left of the Enemy's Line begin to waver, and crowd together, and ordered the British and Pied-montefe under my Command to rush forward, which they did with the utmost Spirit and Alacrity, under an heavy and galling Fire of the Ene-my, which, however, was of very flort Duration, for the whole Line of the Enemy, with their different Corps of Referve, (400 of their Troops having abandoned the Redoubt before the Conclufion of the Action) were thrown into Confu-fion, and the Rout became general; feveral were killed in the Pursuit, but a very confiderable Number indeed were deftroyed by preffing each other over the Precipice in their Flight; 75 of their Dead were collected, without defcending into the Valley to which they fell from the Precipice : An Officer and 60 Prifoners were taken ; and, by Accounts

counts since received from Deserters, but one Quarter of their original Number have rejoined their Forces. The molt moderate Calculation upon the Accounts of the Priloners and Deferters, ftates their Numbers to have been from 1800 to 2000 Men, all Troops of the Line, and the Flower of La Bar's Army. Our Lofs has been inconfiderable, compared with the Difficulty and Hazard of the Enterprize : I have to regret the Lofs of Lieutenant the Chevalier Fabar, of the Piedmontese Chasseurs, a gallant, active and intel-ligent young Officer, who was killed at the Commencement of the first Attack made by my Co. lumn. The whole Army heard with Regret that General Gravina, in the Courfe of his able and fpirited Exertions at the Head of the Neapolitan Grenadiers, received a Wound in the Leg, which obliged him to retire from the Field; I am happy, however, to add, that the Wound is not likely be attended with any ferious. Consequences : His Place was ably supplied by the Courage and Con-duct of Brigadier-General Chevalier Squierdo and Prince Pignatelli. I inclose a Lift of the Killed and Wounded of the different Nations ; the chief Lofs has fallen upon the Column under my Command, from the very exposed Situation in which the Attack was neceffarily made, and where the British and Piedmontese Troops justified the mutual Confidence which each feemed to repofe in the fleady Support of the other. Indeed, Sir, I fhould do Injuffice were I to particularize any Corps or any Nation, where all were fo equally meritorious, not only in the intrepid Firmnels with which the Whole of this brave Body of Men encountered the Dangers of a difficult and almost desperate Attempt, but for the patient Fortitude, also, with which they bore Hunger, Thirst and Fatigue, the Troops having received only a fmall Particle, the Froops having received only a main Portion of Bread at the Time they marched from out of the Town, and being (from the Want of neceffary Supplies at Toulon) without Canteens, no Officer or Soldier had a Drop of Water to re-fresh him during the Space of Twelve Hours, in a laborious March up Precipices fuppofed inacceffible, and over rugged Rocks, exposed to the Heat of a burning Sun, reflected firongly by the Nature of the Ground. I can only fay, that the mutual Effeem and Applause; which the Troops of the different; Nations fo strongly manifest to. wards each other, is the most honorable Panegyrick that can be beflowed upon them.

I N Conformity to the Plan fixed on for our joint Operations, I went up to Fort Faron, and, by thewing the Head of different Columns of the Troops, kept the Enemy conftantly jealous of an immediate Attack on the Right, and kept up a well-directed Fire from Three Twelve-Pounders on the Redoubt: But it was not only my own Opinion but that of all the Officers commanding Corps, that a direct Attack in a Work fo fituated and full of Men was impracticable; I therefore ordered Four Parties, of Sixty Men each, to be ready to climb up the Hill the Moment General Gravina and your Lordship should advance on the Top of the Mountain, and a Column of Two Hundred to follow and fupport them, without firing until they fhould arrive at the Summit, and a Party to turn the Hill lower down on the Right, to cut off or impede the Retreat, and all the Guns of the Fort to fire about Fifty Yards in Front of the Troops,

Troops, and to ftop the Moment I fhould make a Signal. This Plan was admirably executed, and, I hope, preduced the heft Effect; Conde del Perefta, Colonel of the Regiment of Majorca, diffinguilhed himfelf much in conducting the Attack. Captains Torriano of the 30th and Beresford of the 50th had infinite Merit for the intrepid Manner they led their Men up an almost inaccessible Mountain, under a fevere Fire. The Commandant of the Neapolitan Troops, and Major Heuffein of the Regiment of Royal Louis, were not lefs diffinguished on this Occafion, and the Whole behaved with exemplary Firmniefs. Lieutenant Alexander of the Navy and Captain Dexter of the Marines performed molt material Services by the well directed Fire from Guns on the Enemy's Troops and Works.
