Have the Satisfaction to inclose you, for their Lordships' Information, a Letter that I have received from Lieutenant Bengelly, commanding His Majelty's Cutter Viper, flating his having captured and carried into Falmouth, Le Furet French Privateer of Fourteen Guns.

I am happy on this Occasion to congratulate their Lordships on the Zeal and Gallantry difplayed by Lieutenant Pengelly and the Officers and Crew. of the Viper, which excite my high Commendation.

His Majefly's Cutter, Viper, Falmouth,

December 28, 1799.

Have the Honor to acquaint you, that on the 26th Inflant, at a Quarter pail Ten, A. M. the Dodman, bearing North Seven or Eight Leagues, I discovered a fuspicious Vessel to Windward, standing towards the Viper, under my Command; at Noon perceiving her to be an Enemy, tacked, and ftood towards her, and at a Quarter past brought her to close Action, which continued for Three Quarters of an Hour, when the theered off; I had the good Fortune, however, after a running Fight of an Hour and a Half to lay her close on board, and upon pouring Two Broadfides into her the ftruck her Colours; the proves to be Le Furet, of Fourteen Guns, Four-Pounders, commanded by Citoyen Louis Bouvet, Two Days from St. Maloes, with a Complement of Sixty-four Men, Seven of which had been fent away in a Prize on the Morning of the Day she was captured. Le Furet is quite new, this being her first Cruize, is well stored and victualled for Two Months.

I cannot fpeak too much in Praife of Mr. Henry Jane, acting Mafter, from whofe Zeal and Ability I received every Affiftance, nor can I be fully ex-prefive of the fpirited and good Conduct of the Officers and Ship's Company.

I am happy to add that we had only One Man wounded, and myfelf flightly hurt; the Sails and Rigging much cut, and the Mainmaft, I am appre-

henlive, rendered unferviceable. The Lofs of the Enemy was Four Men killed; the First and Second Captains and Six Men

wounded; Four dangeroufly. The Prize, as well as the Viper, being much difabled in her Sails and Rigging, I have put into Falmouth, from whence I shall proceed to Plymouth as foon as poffible.
