A PROCLAMATION.

GEORGE, P. R.

HEREAS a Definitive Treaty of Peace and Friendship between His Majesty and His Most Christian Majesty hath been concluded at Paris on the thirtieth day of May last; in conformity thereunto, We have thought fit, in the name and on the behalf of His Majesty, hereby to command, that the same be published throughout all

His Majesty's dominions; and We do declare to all His Majesty's loving subjects Our will and pleasure, that the said Treaty of Peace and Friendship be observed inviolably, as well by sea as land, and in all places whatsoever; strictly charging and commanding all His Majesty's loving subjects to take notice hereof, and to conform themselves thereunto accordingly.

Given at the Court at Carlton-House, the seventeenth day of June, one thousand eight hundred and fourteen, and in the fifty-fourth year of His Majesty's reign.

that a General Thanksgiving to Almighty God for these His mercies, be observed throughout those parts of the United Kingdom called England and Ireland, on Thursday the seventh day of July next; and for the better and more devout solemnization of the same, We have given directions to the Most Reverend the Archbishops, and the Right Reverend the Bishops of England, to compose a Form of Prayer, suitable to this occasion, to be used in all churches and chapels, and other places of public worship, and to take care for the timely dispersing of the same throughout their respective dioceses; and We do strictly charge and command, that the said public Day of Thanksgiving be religiously observed by all His Majesty's loving subjects, as they tender the favour of Almighty God, and upon pain of suffering such punishment as may be justly inflicted upon all such as shall contemn or neglect the same.

HEREAS it has pleased Almighty God, in His great goodness, to put an end to the long, extended, and bloody warfare in which We were engaged against France and her Allies; We, therefore, adoring the Divine goodness, and duly considering, that the great and public blessings of peace do call for public and solemn acknowledgments, have thought fit, in the name and on the behalf of His Majesty, and by and with the advice of His Majesty's Privy Council, to issue this Proclamation, hereby appointing and commanding, that a General Thanksgiving to Almighty God for these His mercies, be observed throughout that part of the United Kingdom called Scotland, upon Thursday the seventh day of July next; and We do strictly charge and command, that the said public Thanksgiving be reverently and decently ob-

served by all His Majesty's loving subjects'in Scotland, on the said seventh day of July next, as they tender the favour of Almighty God, and would avoid His wrath and indignation, and upon pain of such punishment as may be justly inflicted on all such as contemn or neglect the performance of so religious a duty: Our will and pleasure is. therefore, and We charge, that this Our Proclamation seen, ye pass to the Market-Cross of Edinburgh, and all other places needful, and there. in His Majesty's name and authority, make publication thereof, that none pretend ignorance: and Our will and pleasure is, that His Majesty's Solicitor do cause printed copies hereof to be sent to the Sheriffs of the several shires, Stewarts of stewartries, and Bailiffs of regalities, and their Clerks, whom We ordain to see the same published; and We appoint them to send copies thereof to the several parish churches within their bounds, that, upon the Lord's Day immediately preceding the day above-mentioned, the same may be published and read from the pulpits immediately after Divine

It is with equal pride and pleasure that we hail your Royal Highness's arrival at this seat of religion and learning, adorned by so many monuments of royal munificence, enriched by your Royal Highness with additional treasures of antient literature, and honoured by still more recent marks of your

Royal countenance and protection.

These sentiments we should at all times and under any circumstances have been happy to be permitted to express to your Royal Highness in this place. For this signal instance of Divine protection, we beg leave to assure your Royal Highness that our gratitude shall be manifested by the pursuit of those studies and the cultivation of those airts and sciences, by which peace is best adorned and pro-longed. It shall be our constant endeavour to inform and improve the youth committed to our care; and to establish in their minds, on the sure basis of reason and revelation, the sacred duties of public and private life. It is thus that we hope to train up the rising generation in the principles of invio-lable loyalty to the throne, and of affectionate veneration for that happy constitution which has been our safe-guard in this long season of trial; the admiration of other nations, the theme of their gratitude, and the object of their imitation.

That your Royal Highness and your august Allies may long enjoy the satisfaction arising from your enlightened views and heroic achievements in the cause of suffering humanity, by seeing your dominions flourishing, your subjects happy, and the world at peace, is the devout and fervent prayer of your Royal Highness's antient and loyal Univer-

sity of Oxford.

Given at our House of Convocation, under our Common Seal, this thirteenth day of June, in the year of our Lord, one thousand eight hundred and fourteen.

It will always be my earnest wish to consolidate and maintain it. May it long continue to diffuse over this ancient seat of learning and religion, the means of cultivating those arts and sciences which are its best and brightest ornament."
