WHEREAS under or by virtue of a Convention for the reciprocal protection of copyright concluded between Her Majesty and His Majesty the King of Prussia, on the thirteenth day of May one thousand eight hundred and forty-six, and an Act of Accession dated the first day of July one thousand eight hundred and forty-seven, entered into, in pursuance of a stipulation in the said Treaty contained, by the following States forming the Thuringian Union (that is to say), His Royal Highness the Grand Duke of Saxe-Weimar-Eisenach, Their Royal Highnesses the Dukes of Saxe-Altenburg, Saxe-Coburg-Gotha, and Saxe-Meiningen, Their Serene Highnesses the Princes of Schwarzburg-Rudolstadt and Schwarzburg-Sondershausen, Reuss-Greiz, Reuss-Lobenstein-Eberdorf, and Reuss-Schleitz, due protection has been secured within the dominions of the said States forming the Thuringian Union, for the authors of books, dramatic pieces, or musical compositions, and the inventors, designers, or engravers of prints and articles of sculpture, and the authors, inventors, designers, or en-

gravers of any other works whatsoever of literature and the fine arts, in which the laws of Great Britain and of the said States do now or may hereafter give their respective subjects the privilege of copyright, and for the lawful representatives or assigns of any such authors, inventors, designers, or engravers, with regard to any such works first published within the dominions of Her Majesty:

Now, therefore, Her Majesty, by and with the advice and consent of Her Privy Council, and by virtue of the authority committed to Her by an Act, passed in the session of Parliament holden in the seventh and eighth years of Her reign, intituled "An Act to amend the law relating to international copyright," doth order, and it is hereby ordered, that, from and after the day of the date of this Order, the authors, inventors, designers, engravers, and makers of any of the following works (that is to say), books, prints, articles of sculpture, dramatic works, musical compositions, and any other works of literature and the fine arts, in which the laws of Great Britain give to British subjects the privilege of copyright, and the executors, administrators, and assigns of such authors, inventors, designers, engravers, and makers, respectively, shall, as respects works first published within the dominions of the said States forming the Thuringian Union, or any of

them, after the fifteenth day of July one thousand eight hundred and forty-seven, have the privilege of copyright therein for a period equal to the term of copyright which authors, inventors, designers, engravers, and makers of the like works, respectively, first published in the United Kingdom are by law entitled to, provided such books, dramatic pieces, musical compositions, prints, articles of sculpture, or other works of art have been registered, and copies thereof have been delivered according to the requirements of the said recited Act, within twelve months after the first publication thereof, in any part of the dominions of the said States:

And it is hereby further ordered, that the authors of dramatic pieces and musical compositions which shall, after the said fifteenth day of July one thousand eight hundred and forty-seven, be first publicly represented or performed within the dominions of the said States, shall have the sole liberty of representing or performing in any part of the British dominions such dramatic pieces or musical compositions, during a period equal to the period during which authors of dramatic pieces and musical compositions first publicly represented or performed in the United Kingdom are entitled by law to the sole liberty of representing or performing the same; provided such dramatic pieces or musical compositions have been registered, and copies thereof have been delivered according to the requirements of the said recited Act, within twelve calendar months after the time of their being first represented or performed in any part of the dominions of the said States:

And the Right Honourable the Lords Commissioners of Her Majesty's Treasury are to give the necessary orders herein accordingly.

WHEREAS by an Act, passed in the session of Parliament holden in the ninth and tenth years of the reign of Her present Majesty, intituled "An Act to amend an Act of the seventh

"and eighth years of Her present Majesty, for reducing, under certain circumstances, the duties payable upon books and engravings," it is enacted, that whenever Her Majesty has, by virtue of any authority vested in Her for that purpose, declared, that the authors, inventors, designers, engravers, or makers of any books, prints, or other works of art, first published in any foreign country or countries, shall have the privilege of copyright therein, it shall be lawful for Her Majesty, if she think fit, from time to time, by any Order in Council, to declare that, from and after a day to be named in such Order, in lieu of the duties of Customs from time to time payable on the importation into the United Kingdom of books, prints, and drawings, there shall be payable only such duties of Customs as are mentioned in the said Act:

And whereas Her Majesty hath this day, by virtue of the authority vested in Her for that purpose, declared that the authors, inventors, designers, engravers, and makers of books, prints, and certain other works of art, first published within the dominions of the States hereinafter mentioned, forming the Thuringian Union, shall have the privilege of copyright therein:

Now, therefore, Her Majesty, by and with the advice and consent of Her Privy Council, and in virtue of the authority committed to Her by the said recited Act, doth order, and it is hereby ordered, that, from and after the day of the date of this Order, in lieu of the duties of Customs now payable upon books, prints, and drawings, published at any place within the dominions of the following States forming the Thuringian Union (namely), His Royal Highness the Grand Duke of Saxe-Weimar-Eisenach, Their Royal Highnesses the Dukes of Saxe-Altenburg, Saxe-Coburg-Gotha, and Saxe-Meiningen; Their Serene Highnesses the Princes of Schwarzburg-Rudolstadt and Schwarzburg-Sondershausen, Reuss-Greiz, Reuss-Lobenstein-Eberdorf, and Reuss Schleitz, there shall be payable only the duties of Customs following (that is to say):

On books originally produced in the United Kingdom, and republished at any place within the dominions of the said States, a duty of two pounds ten shillings per hundred weight.

On books published or republished at any place within the dominions of the said States, and not being books originally produced in the United Kingdom, a duty of fifteen shillings per hundred weight.

On prints and drawings, plain or coloured, published at any place within the dominions of the said States,

Single, each, - - - -	0½d.
Bound or sewn, the dozen, -	1½d.

And the Right Honourable the Lords Commissioners of Her Majesty's Treasury are to give the necessary orders herein accordingly.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of an Act, passed in the session of Parliament held in the sixth and seventh years of Her Majesty's reign, intituled "An Act to make better provision for the spiritual care of populous parishes," duly prepared and laid before Her Majesty in Council a scheme, bearing date the seventh day of August, in the year one thousand eight hundred and forty-seven, in the words following, that is to say:

"We, the Ecclesiastical Commissioners for England, in pursuance of an Act, passed in the session of Parliament held in the sixth and seventh years of your Majesty's reign, intituled "An Act to make better provision for the spiritual care of populous parishes," have prepared, and now humbly lay before your Majesty in Council, the following scheme, for constituting a separate district for spiritual purposes out of the parish of Leeds, in the west riding of the county of York, and in the diocese of Ripon.

"Whereas it is by the said Act enacted, that if at any time it shall be made to appear to us, that it would promote the interests of religion, that any part or parts of any parish or parishes, chapelry or chapelries, district or districts, of great extent,

and containing a large population, and wherein, or in parts whereof, the provision for public worship and for pastoral superintendence is insufficient for the spiritual wants of the inhabitants thereof, or any extra-parochial place or places, or any part or parts thereof, should be constituted a separate district for spiritual purposes, it shall be lawful, by the authority in the same Act provided (that is to say, by a scheme prepared by us, and an Order issued by your Majesty in Council, ratifying such scheme), with the consent of the bishop of the diocese, under his hand and seal, to set out by metes and bounds, and constitute a separate district accordingly, such district not then containing within its limits any consecrated church or chapel in use for the purposes of divine worship, and to fix and declare the name of such district; and it is by the same Act provided, that the draft of any scheme for constituting any such district shall be delivered or transmitted to the incumbent and to the patron or patrons of the church or chapel of any parish, chapelry, or district out of which it is recommended that any such district, or any part thereof, should be taken, in order that such incumbent, patron or patrons, may have an opportunity of offering or making to us, or to such bishop, any observations or objections upon or to the constituting of such district; and that such scheme shall not be laid before your Majesty in Council until after the expiration of one calendar month next after such copy shall have been so delivered or transmitted, unless such incumbent and patron or patrons shall, in the mean time, consent to the same; and it is by the same Act also provided, that in every such scheme for constituting any such district we shall recommend to your Majesty in Council that the minister of such district, when duly licensed according to the same Act, shall be permanently endowed, under the provisions of the same Act, to an amount of not less than the annual value of one hundred pounds; and also, if such endowment be of less than the annual value of one hundred and fifty pounds, that the same shall be increased to such last-mentioned amount at the least, so soon as such district shall have become a new parish as thereafter provided:

"And whereas the said parish of Leeds is of great extent, and contains a large population, and the provision for public worship and for pastoral superintendence therein is insufficient

for the spiritual wants of the inhabitants thereof; and it has been made to appear to us, that it would promote the interests of religion, that the particular part of such parish hereinafter mentioned, such part not at present containing within its limits any consecrated church or chapel in use for the purposes of divine worship, should be constituted a separate district in manner hereinafter set forth :

“ Now, therefore, we humbly recommend and propose, with the consent of the Right Reverend Charles Thomas Bishop of Ripon, in testimony whereof he has signed and sealed this scheme, that all that part of the said parish of Leeds, described in the schedule hereunto annexed,—all which part, together with the boundaries thereof, is delineated and set forth in the map or plan hereunto also annexed,—shall be constituted a separate district for spiritual purposes accordingly, and that the same shall be named, “ The District of All Saints, Leeds.”

“ And we further recommend and propose, that there shall be paid by us, in each and every year, to the minister for the time being of the district so recommended to be constituted, when duly licensed according to the said Act, the sum of one hundred pounds; and upon any building within such district being duly licensed by the bishop of the diocese for the performance of divine service, according to the same Act, there shall be paid by us, in like manner, to such minister, the further sum of thirty pounds, making in the whole the sum of one hundred and thirty pounds; and that so soon as any church or chapel within such district shall have been duly approved by us, and consecrated as the church or chapel of such district, for the use and service of the minister and inhabitants thereof, and such district shall have thereupon become, according to the provisions of the same Act, a new parish for ecclesiastical purposes, there shall be paid by us, in each and every year, to the perpetual curate for the time being of such new parish, the sum of one hundred and fifty pounds; and that the said sum of one hundred pounds, one hundred and thirty pounds, or one hundred and fifty pounds, as the case may be, shall be paid, by equal half-yearly payments, on the first day of May and the first day of November in each and every year; and that the first such payment, or

a proportionate part thereof, shall be made on the first day of May or of November next after the day of the date of the licence of such minister or of such building, or of the consecration of such church or chapel as aforesaid, as the case be; and that in case a vacancy in the ministry or perpetual curacy of such district or new parish shall happen on any other day than the first day of May or the first day of November, the amount payable shall be duly apportioned between and paid to the minister or the perpetual curate making the vacancy, or his personal representative or representatives, and the minister or the perpetual curate succeeding to such district or new parish.

“ And we further recommend and propose, that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Act, or of any other Act of Parliament.

“ SCHEDULE.

“ The district of ALL SAINTS, Leeds, being,—

“ All that part of the parish of Leeds, in the west riding of the county of York, and in the diocese of Ripon, comprised within and bounded by an imaginary line commencing at a point (marked *a* on the map or plan hereunto annexed) in the middle of York-street, and opposite to the middle of Helen-court, and thence extending towards the north east along the middle of such street as far as Marsh-lane, and thence in the same direction, along the middle of such lane and of the York-road, and of the Leeds and Selby, and Tadcaster and Halton Dial turnpike roads, as far as the eastern boundary of the said parish, and thence southward along such boundary as far as the northern boundary of the district of Saint Saviour, Leeds, in the said diocese, and thence westward along such last-mentioned boundary as far as the middle of Richmond-road, and thence northward along the middle of such road to a point (marked *b* as aforesaid) opposite to the middle of Mill-street, and thence westward along the middle of such last-mentioned street to a point (marked *c* as aforesaid) opposite to the middle of Upper Cross-street, and thence northward along the middle of such last-mentioned street as far as the middle of Railway-street, and

thence westward along the middle of such last-mentioned street as far as Marsh-lane aforesaid, and thence northward along the middle of such lane to a point (marked *d* as aforesaid) opposite to the middle of Red Bear-yard, and thence westward along the middle of such yard and of Helen-court aforesaid to the point where the said imaginary line commenced."

And whereas the draft of the said scheme has been transmitted to the incumbent and to the patrons of the church of the parish out of which it is intended that the district therein recommended to be constituted shall be taken, pursuant to the provisions of the said Act; and such incumbent and patrons have consented to the said scheme :

And whereas the said scheme has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same, and every part thereof, shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette, pursuant to the said Act; and Her Majesty, by and with the like advice, is pleased hereby to direct, that this Order be forthwith registered by the Registrar of the diocese of Ripon.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of an Act, passed in the last session of Parliament, intituled "An Act for establishing the bishopric of Manchester, and amending certain Acts relating to the Ecclesiastical Commissioners for England," and of certain other Acts therein recited, duly prepared and laid before Her Majesty in Council a scheme, bearing date the seventh day of August one thousand eight hundred and forty-seven, in the words and figures following, that is to say :

"We, the Ecclesiastical Commissioners for England, in pursuance of an Act, passed in the last session of Parliament, intituled "An Act for establishing the bishopric of Manchester, and amending certain Acts relating to the Ecclesiastical Commissioners for England," and of certain Acts therein recited, have prepared, and now humbly lay before your Majesty in Council, the following scheme, for founding and endowing the bishopric of Manchester, and for founding certain archdeaconries.

"Whereas the above recited Act and certain other Acts of Parliament therein recited contain provisions for the immediate foundation and endowment of a bishopric of Manchester, and for carrying into effect the arrangements connected therewith and incidental thereto as herein-after recommended :

"And whereas we have obtained the consent of the Right Reverend John Bird Bishop of Chester to the recommendations hereinafter contained ; in testimony whereof, he has signed and sealed this scheme :

"We humbly recommend and propose that, upon and from the first day of September next, the collegiate church of Manchester shall be constituted and become and shall for ever thereafter be a cathedral church and the seat of a bishop within the province of York, and shall be invested with all the honours, dignities and privileges of a cathedral church and episcopal seat, and that the dean and canons of the said cathedral church shall be the dean and chapter thereof.

"And we further recommend and propose that, upon and from the same day, the deaneries of Amounderness, Blackburn, Manchester, and Leyland, and the whole parish of Leigh, including the townships of Astley, Atherton, Bedford, Pennington, Tyldesley with Shakerley, and Westleigh, otherwise Leigh, in the deanry of Warrington, all in the county of Lancaster and diocese of Chester, together with such parts of the respective deaneries of Kendal and Kirkby Lonsdale in the same diocese as are in the same county, shall be detached and dis severed from the said diocese of Chester, and shall be made and constituted and shall become and for ever thereafter be and be called and known by the name of the diocese of Manchester ; and all parishes and

places, churches and chapels, and the whole clergy and others your Majesty's subjects within the limits thereof shall be exempted and released from all jurisdiction, authority and control of the Bishop of Chester, and shall be under and subject to the episcopal jurisdiction, authority and control of the Bishop of Manchester when duly constituted as herein-after provided and of his successors Bishops of Manchester for ever.

"And we further recommend and propose, that such person as shall be duly elected by the said Dean and Chapter of Manchester, in pursuance of a warrant from your Majesty in that behalf, and shall be duly confirmed and consecrated according to law, shall become bishop of the said see and diocese of Manchester, and shall become and be invested with all the same and the like rights, privileges, dignities, power, jurisdiction and authority as have heretofore been and now are possessed by the Bishop of Ripon; save only so far as such rights, privileges or dignities are affected by any of the provisions of the herein-before recited Act.

"And we further recommend and propose, that the said bishop and his successors bishops of the said see and diocese of Manchester shall be a body corporate by the name of the Bishop of Manchester, and by that name shall have perpetual succession and a common seal, and shall and may by that name sue and be sued, and shall have power and authority to take and hold all lands, tithes, advowsons, tenements and hereditaments, whatsoever and wheresoever, which may be given or granted to him or them by your Majesty, your heirs and successors, or by any other person or body corporate, and shall enjoy and may do all rights and acts, in respect of the same, in as full and perfect a manner as the Bishop of Ripon, but not otherwise.

"And we further recommend and propose, that the said cathedral church of Manchester shall be the cathedral church of the said bishop, and of his successors bishops of Manchester, who shall enjoy and exercise episcopal pre-eminence, jurisdiction, power and authority within and over the said church and the aforesaid diocese of Manchester, in as full and ample a manner as the Bishop of Ripon within and over his diocese and the cathedral church thereof, and that the said Bishop of Manchester and the said Dean and Chapter of Man-

chester and the archdeacons and the whole clergy and others your Majesty's subjects within the said diocese of Manchester, shall be subject to the metropolitan jurisdiction of and shall own obedience to the Archbishop of York and his successors Archbishops of York.

"And we further recommend and propose, that the said Bishop of Manchester and his successors Bishops of Manchester, and the said Dean and Chapter of the cathedral church of Manchester and their successors, shall have full power and authority to do all acts and deeds, whether jointly or severally as the case may be, within the said diocese of Manchester, in like manner and as fully and effectually as the Bishop of Ripon and the Dean and Chapter of the cathedral church of Ripon may now do, either jointly or severally as the case may be.

"And we further recommend and propose, that the said Bishop of Manchester and his successors Bishops of Manchester shall be endowed with an average annual income of four thousand two hundred pounds, in such manner as shall be hereafter determined, in conformity with the provisions of the said Acts; and that we shall, as soon as conveniently may be, lay before your Majesty in Council a scheme for fixing the mode of such endowment.

"And we further recommend and propose that, upon and after the confirmation of the Bishop of Manchester as aforesaid, but subject to such apportionment of ecclesiastical patronage among the several bishops as shall be made by any Order of your Majesty in Counsel, in pursuance of the provisions of the Statute in that behalf, the patronage of all benefices heretofore or now belonging to any prebendary in the collegiate church of Southwell, to which benefices, as they respectively become vacant, the Bishop of Ripon for the time being might now by law present, shall become and be divided equally between, and shall and may be exercised alternately by, the Bishop of Ripon and the Bishop of Manchester for the time being; the Bishop of Ripon presenting to the benefice which shall first become vacant, and the Bishop of Manchester presenting to the benefice which shall secondly become vacant, after such confirmation of the Bishop of Manchester aforesaid, and so from time to time as vacancies may occur.

“And we further recommend and propose, that the said diocese of Manchester, when so constituted as aforesaid, shall immediately thereupon become and be divided into two archdeaconries, which shall be styled and called respectively the archdeaconry of Manchester and the archdeaconry of Lancaster; and the archdeaconry of Manchester shall, notwithstanding any previous Order of your Majesty in Council, consist of the said deaneries of Blackburn, Manchester, and Leyland and the whole parish of Leigh including the townships aforesaid; and the said parish of Leigh shall be detached from the deanry of Warrington, and shall be included in and form part of the deanry of Manchester; and the archdeaconry of Lancaster shall consist of the deanry of Amounderness and so much of the deaneries of Kendal and Kirkby Lonsdale as are herein-before proposed to be included in the said diocese of Manchester; and the aforesaid portions of the deaneries of Kendal and Kirkby Lonsdale shall be detached from the said deaneries, and shall be united and shall together constitute and be called the deanry of Tunstall.

“And we further recommend and propose, that there shall at the same time be constituted in the diocese of Chester a new archdeaconry, which shall be styled and called the archdeaconry of Liverpool; and the said archdeaconry shall consist of the deanry of Worrall, in the county of Chester, and the said deanry of Warrington so altered as aforesaid:

“And we further recommend and propose, that all parishes and places, churches and chapels, and the whole clergy and others your Majesty's subjects locally situated within the said archdeaconries of Manchester, Lancaster, and Liverpool respectively,—shall be under and subject to the jurisdiction of the Archdeacons of Manchester, Lancaster, and Liverpool, for the time being, respectively, and shall thenceforth be released and discharged from all other archidiaconal jurisdiction whatsoever, and from any jurisdiction, authority or control in the nature thereof.

“And we further recommend and propose, that the Venerable John Rushton, Doctor in Divinity, who was collated by the said John Bird Bishop of Chester to the archdeaconry of Manchester founded in the diocese of Chester, shall, upon

and from the day of the confirmation of the Bishop of Manchester as aforesaid, and by the sole operation of this scheme and any duly gazetted Order of your Majesty in Council ratifying the same, be and continue to be, to all intents and purposes, Archdeacon of the archdeaconry of Manchester in the diocese of Manchester; and that the Bishop of Manchester, when fully confirmed as aforesaid, shall and may collate some fit and proper person to the dignity or office of archdeacon of the said archdeaconry of Lancaster; and that the Bishop of Chester, for the time being, shall and may collate some fit and proper person to the dignity or office of archdeacon of the said archdeaconry of Liverpool; and the right of collating the archdeacons of Manchester and Lancaster shall be vested in the said Bishop of Manchester and his successors bishops of Manchester for ever; and the right of collating the archdeacon of Liverpool shall be vested in the said John Bird Bishop of Chester and his successors Bishops of Chester for ever.

“And we further recommend and propose, that upon the next avoidance of the see of Carlisle, or sooner with the consent under the hand and seal of the present Bishop of Carlisle, and in the latter case upon and from the fourteenth day next following the publication of such consent in the London Gazette, that portion of the deanry of Kirkby Lonsdale which is in the county of Westmoreland shall be annexed to that portion of the deanry of Kendal which is in the same county, and the same shall together constitute and be called the deanry of Kendal; and the said deanry of Kendal, and the deanry of Coupland in the county of Cumberland, and the deanry of Furnes and Cartmel in the county of Lancaster, shall be detached and dis severed from the diocese of Chester of which they now form part, and shall become and be permanently annexed and united to and included in and form part of the diocese of Carlisle; and all parishes and places, churches and chapels, and the whole clergy and others your Majesty's subjects within the limits of the said deaneries of Kendal, Coupland, and Furnes and Cartmel, shall be thenceforth exempted and released from all jurisdiction, authority and control of the Bishop of Chester, and shall be under and subject to the

episcopal jurisdiction, authority and control of the Bishop of Carlisle, for the time being, for ever; and under the archidiaconal jurisdiction of the archdeacon of the archdeaconry of Westmoreland, as hereinafter proposed to be constituted, and shall be subject to no other archidiaconal jurisdiction whatsoever, nor to any jurisdiction, authority or control in the nature thereof.

“And we further recommend and propose, that upon such addition as aforesaid being made to the said diocese of Carlisle, a new archdeaconry shall be created in the same diocese, which shall be styled and called the archdeaconry of Westmoreland; and the said archdeaconry shall consist of the said deanries of Kendal, Furnes and Cartmel, and Coupland; and the said archdeaconry and also the archdeaconry of Carlisle shall be subject to such alterations as may hereafter be deemed expedient.

“And we further recommend and propose, that the Bishop of Carlisle for the time being shall and may collate some fit and proper person to the dignity or office of archdeacon of the said archdeaconry of Westmoreland; and that the right of collating the archdeacon of Westmoreland shall be vested in the Bishop of Carlisle, and his successors Bishops of Carlisle for ever.

“And we further recommend and propose, that nothing herein contained shall prevent us from recommending and proposing any further measures relating to the matters aforesaid, or any of them, in conformity with the provisions of the said recited Act, or any other Act of Parliament; and especially for providing such endowments as shall be deemed fit and proper for the archdeacons of the several archdeaconries hereinbefore mentioned.”

And whereas the said scheme has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same, and every part thereof, shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette; and Her Majesty, by and with the like advice, is pleased hereby to direct, that this Order be forthwith registered by the Regis-

“We, the Ecclesiastical Commissioners for England, in pursuance of an Act, passed in the session of Parliament held in the fifth and sixth years of your Majesty's reign, intituled “An Act to alter and amend the law relating to ecclesiastical houses of residence,” have prepared, and now humbly lay before your Majesty in Council, the following scheme, respecting the alteration and improvement of the episcopal house of residence at Wells.

“Whereas by an Order of your Majesty in Council, bearing date the sixth day of July, in the year one thousand eight hundred and forty-six, ratifying a scheme prepared by us, dated the first day of the same month, sanction was given, under the said Act, to the borrowing by the Bishop of Bath and Wells of the sum of three thousand pounds by way of mortgage, for adding to, altering and improving the said episcopal house of residence; and the said Order has been duly gazetted:

“And whereas it has since been made to appear to us, that, for the repair and restoration

of the chapel attached to such episcopal house of residence, there will be required a further sum of one thousand pounds, and we are of opinion, after full consideration of all the circumstances of the case, that it will be just and proper to sanction the borrowing by the said bishop, in like manner, of the said further sum of one thousand pounds (which, together with the said sum of three thousand pounds, will be less than one year's income of the see of Bath and Wells):

“ We, therefore, humbly recommend and propose, with the consent of the Honourable and Right Reverend Richard Bishop of Bath and Wells, testified by his having hereunto set his hand and episcopal seal, that he the said bishop be authorized to borrow from the Governors of the Bounty of Queen Anne, and that the said Governors be empowered to lend, under the provisions of the said Act, and the other Act in the said Order recited, the further sum of one thousand pounds, and as a security for the same, and the interest thereof, and all costs and charges attending the recovery of the same respectively, that the said Richard Bishop of Bath and Wells do mortgage (by way of further charge thereon) all or any part of the lands, tenements and hereditaments of and belonging to his said see to the said Governors, or otherwise as they may direct; and that such principal sum shall be repaid with interest, in manner following, that is to say, from and after the expiration of the first year of the said term, computed from the day of the date of the mortgage, in which year no part of the said principal sum shall be repayable, the said Richard Bishop of Bath and Wells, or his successors, shall yearly and every year pay to the said Governors, their successors or assigns, one thirtieth part of the said principal sum, until the whole thereof shall be repaid, and shall, at the end of the first and each succeeding year, pay interest, at the rate of three pounds ten shillings per centum per annum, on the said principal sum, or on so much thereof as shall from time to time remain unpaid; and if and when it shall happen that the principal and interest, directed to be paid as hereinbefore mentioned, shall be in arrear and unpaid for the space of forty days after the same shall have become due, it shall and may be lawful for the said Governors, their successors or assigns, to recover the same, and the costs and charges

attending the recovery thereof, by distress and sale in such manner as rents may be recovered by landlords or lessors from their tenants by the laws in being at the time of such distress and sale; and such mortgage deed shall be in the form and to the effect to be approved by us and the said Governors, and shall bind as well the said Richard Bishop of Bath and Wells as every succeeding bishop of the said see, until the principal and interest, costs and charges shall be paid off and discharged.

“ And we further recommend and propose, that all the provisions, contained in the said Order of your Majesty in Council of the sixth day of July one thousand eight hundred and forty-six, which relate to a possible deficiency in the intended average annual income of the said bishop and his successors, by reason of the mortgage authorized by the said Order, and also the provisions of the same Order which relate to the payment to and by us of the money thereby authorized to be borrowed, shall respectively be extended and shall apply also to any deficiency which may be created by reason of the further mortgage herein proposed and recommended, and to the payment to and by us of the further sum of money aforesaid.

“ And we further recommend and propose, that nothing herein contained shall prevent us from recommending and proposing other measures relating to the matter aforesaid, in conformity with the said Act, or any other Act of Parliament.”

And whereas the said scheme has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same, and every part thereof, shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette, pursuant to the said Act; and Her Majesty, by and with the like advice, is pleased hereby to direct, that this Order be forthwith registered by the Registrar of the diocese of Bath and Wells.

And whereas by an Act, passed in the session of Parliament holden in the eighth and ninth years of the reign of Her present Majesty, intituled "An Act for granting duties of Customs," it is, amongst other things, enacted and declared, that, from and after the ratification of any treaty heretofore made by Her Majesty, and any of Her royal predecessors, subsequently to the said first hereinbefore recited Act, or of any treaty which may hereafter be made by Her Majesty, Her heirs and successors, with any foreign power, in which treaty have been or shall be contained provisions similar to those recited in the said first hereinbefore recited Act, all and every the provisions, clauses, matters, and things in the said first hereinbefore recited Act contained, shall apply and extend to the trade and shipping of such foreign powers, respectively, as fully and effectually to all intents and purposes as to the trade and shipping of the said United States and of the said kingdom of Portugal, and also shall apply and extend to differential duties or charges on goods imported or exported in the ships of such foreign powers as well as to differential duties on the ships of such foreign powers :

And whereas by the last recited Act it is further enacted, that it shall and may be lawful for Her Majesty, Her heirs and successors, by any Order or Orders to be by Her or them made with the advice of Her or their Privy Council, and published in the London Gazette, from time to time to declare what are the foreign powers with which any such treaty or treaties aforesaid is or

are subsisting, and that the said recited Acts shall apply and shall be deemed, from the time of the ratification of any such treaties, to have been applicable to the trade and shipping of such foreign countries as shall be so mentioned in any such Order or Orders in Council as aforesaid, so long as any such Order or Orders shall continue unrevoked, and no longer :

Now, therefore, Her Majesty, by and with the advice of Her Privy Council, and, in pursuance and exercise of the powers vested in Her by the said Act of the eighth and ninth years of Her Majesty's reign, doth hereby declare, that a treaty has been concluded and is now subsisting between Her Majesty and His Imperial and Royal Highness the Grand Duke of Tuscany :

And the Right Honourable the Lords Commissioners of Her Majesty's Treasury are to give the necessary directions herein accordingly.
