WHEREAS an Act was passed in the thirtieth and thirty-first years of the reign of Her present Majesty Queen Victoria, intituled "An Act to consolidate and amend the law relating to "The Public Health in Scotland;" and by the thirty-first section of the said Act it is enacted, that "whenever any part of the United Kingdom appears to be threatened with, or is affected by, any formidable epidemic, endemic, or contagious disease, the Lords and others of Her Majesty's Most Honourable Privy Council, or any three or more of them, (the Lord President of the Council or one of Her Majesty's Principal Secretaries of State being one), may, by Order or Orders by them from time to time made, direct that the provisions for the prevention of diseases, contained in Part III hereof, be put in force in Scotland, or in such parts thereof, or in such places therein, as in such Order or Orders may be expressed, and may from time to time, as to all or any of the parts or places to which any such Order or Orders extend, and in like manner, revoke or renew any such Order; and, subject to revocation and renewal as aforesaid, every such Order shall be in force for six calendar months, or for such shorter period as in such Order shall be expressed; and every such Order of Her Majesty's Privy Council, or any Members thereof as aforesaid, shall be certified under the hand of the Clerk in Ordinary of Her Majesty's Privy Council, and shall be published in the Edinburgh Gazette, and such publication shall be conclusive evidence of such Order."

And whereas the United Kingdom appears to be threatened with a certain epidemic disease, that is to say, the Asiatic Cholera: and whereas it is expedient to make provision thereunto:—

Now, therefore, in exercise of the powers conferred upon them by the above recited section of the said recited Act, the Lords of the Council do order, and it is hereby ordered, that the provisions for the prevention of diseases, contained in Part III of the Act thirty and thirty-first Victoria,

chapter one hundred and one, be put in force in Scotland, for the space of six calendar months, after the publication of this Order in the Edinburgh Gazette. C. L. Peel.

THE Board of Trade have received through the Secretary of State for Foreign Affairs the following translation of a Notice respecting quarantine, issued by the Spanish Government, viz. :—

Extract from Madrid Gazette, July 18, 1884.

In view of the excessive crowd of ships in the foul lazaret ports, and in order to harmonize the interests of the public health with those of commerce, you are instructed to make arrangements for the performance of their quarantine at the stations of observation in the ports of arrival by all vessels subject to three days' observation under existing regulations. Such suspected merchandise (see Article 41 of the Sanitary law) as may be landed from these vessels for introduction into your province, shall be submitted to cleansing (espurgo) and fumigation at the proper place, and in the proper manner.

In other harbours, shipmasters will incur the risk of keeping such patients on board or of remaining meanwhile in quarantine.
