(except as provided in clause 3). At the end of the latter term the Governing Body may extend the tenure of any such scholarship for one year longer if for special reasons, they deem it advisable so to do.

Provided always, that nothing in this clause shall prevent the exercise at any time, for any sufficient cause of the power of deprivation conferred by the Statute hereinafter numbered XXVI, or of the power of inflicting any fines or penalties less than deprivation under any Bylaw of the house for the time being in force.
