

although having had cases of yellow fever during the voyage, have been free therefrom for at least twelve days from the complete restoration or death of the person affected. In such cases it will, moreover, be necessary that the medical officer should make an attestation declaring that the most rigorous disinfection of the effects belonging to the sick persons, and of the place in which they were treated, have been effected.

ART. 4. Shall be directed to the Maritime Sanitary Station, which shall be named in each case by the Ministry, such ships as after having had cases of yellow fever on board shall arrive in a port of the kingdom, and shall not be in the condition mentioned in the preceding Article.

These vessels can also proceed directly to the station of Asinara before touching at any Italian port, in order to undergo the treatment which the Ministry shall have ordained.

ART. 5. It shall in every case be forbidden to ships coming from an infected region to discharge their ballast in port if it consists of earth or sand. Such an operation must be carried out on the high seas at a distance of at least five kilometres from the shore.

ART. 6. It is to be understood that by the present Decree the preceding Ordinance of May 29, 1878, No. 9, is in all respects cancelled.
