THE Queen has been pleased to give and grant unto James Maurice Frost, Pacha, General in the Turkish Army, Her Majesty's Royal licence and authority that he may accept and wear the Insignia of the Second Class of the Order of the Osmanieh, which His Imperial Majesty the Sultan has been pleased to confer upon him in recognition of his services while actually and entirely employed beyond Her Majesty's dominions in the service of His Imperial Majesty.
