THE FAIRS ACT, 1871. The Local Government Act, 1894. SCARBOROUGH FAIRS.

WHEREAS a representation has been duly made to me as Secretary of State for the Home Department, by the Town Council of Scarborough, that Fairs have been annually held in the borough of Scarborough on Holy Thursday and Old Martinmas Day, and on the Thursdays previous to and succeeding St. Swithin's Day and Old Martinmas Day; and that it would be for the convenience and advantage of the public that the said Fairs should be abolished:
