Commencing in Southgate-street, in the parish of St. James, by a junction with Railway No. 5, and passing eastward along Dorchester-street and Railway-place, thence northwards through Manvers-street, Pierrepoint-street, Northparade, and Terrace-walks, thence westwardly into the parish of St. Peter and St. Paul, across Orange-grove, and terminating in High-street in the same parish by a junction with Railway No. 5.

Railway No. 7A. A junction curve, wholly in the parish of St. James, connecting Railway No. 5, in Southgate-street, with Railway No. 7 in Dorchester-street.

Railway No. 7B. A short junction line, wholly in the parish of St. Peter and St. Paul, connecting Railway No. 7, in High-street, with Railway No. 5 in Cheap-street.

Railway No. 8. Commencing in Westgate-place, in the parish of St. Peter and St. Paul, by a junction with Railway No. 2, thence passing south-westerly into the parish of Walcot, across Kingsmead-square, and down New-street, then westerly along James-street, West, and northerly up Charles-street, and terminating by a junc-tion with Railway No. 2 in Monmouth-

place, in the same parish.

Railway No. 9. Commencing at the Old Bridge, in the parish of Lyncombe and Widcombe, by a junction with Railways Nos. 3, 4 and 5 at their commencement, passing thence in a south and south-easterly direction under the Great Western Railway Arch, along Claverton-street to the foot of Widcombe-hill, thence in a north-easterly and northerly direction along the Pulteneyread into the parish of Bathwick, continuing along Pulteney-road through Darlingtonstreet and Sydney-place, thence in a westerly and north-westerly direction along Bathwick-street, Cleveland Bridge-road, over the Cleveland Bridge into the parish of Walcot, and terminating near Cleveland-place, East, iz the London-road, in the same parish, by a junction with Railway No. 5A.

Railway No. 9A. A short junction in Claverton-street, wholly in the parish of Lyncombe and Widcombe, connecting Railway No. 9 with Railway No. 4.

Railway No. 9B. A junction curve in Cleve-land-place, wholly in the parish of Walcot, connecting Railway No. 9 in Cleveland-place with Railway No. 5a in London-road, near Cleveland-place, West.

Railway No. 10. Wholly in the parish of Bathwick, commencing in Sydney-place by a junction with Railway No. 9, thence proceeding in a north-easterly direction along Beckford-road and over the bridge crossing the Great Western Railway, thence easterly and north-easterly along the New Warminster-road, and terminating in that road at the city boundary.

Railway No. 10a. A junction curve, wholly in the parish of Bathwick, connecting Railway No. 10, in Beckford-road, with Railway

No. 9 in Bathwick-street. Railway No. 10s. Wholly in the parish of Bathampton, commencing in the New War-minster-road by a junction with Railway No. 10 at its termination as above described, passing thence in an easterly direction into and along und terminating in that road at a point 2 chains or thereabouts eastward of the junction of the road to Bathampton
