Note Verbale.

Le Ministère des Affaires Etrangères a l'honneur de présenter ses compliments à la Légation de Sa Majesté Britannique et de lui faire parvenir ci-joint quelques exemplaires d'une ordonnance publiée le 12 courant, décrétant, par suite de l'apparition d'une maladie pestilentielle à Port-Saïd.

1. Le mise en vigueur jusqu'à nouvel ordre des dispositions du chapitre 2 II (quarantaine) de la loi du 2 Juillet 1880 concernant les mesures préventives contre l'introduction des maladies contagieuses à l'égard de navires venant de Port Saïd ou ayant communiqué avec ce port ou pendant le voyage avec des navires en provenant. En dehors des cas mentionnés aux §§ 25 et 26 de la dite loi, la quarantaine sera purgée à la station quarantenaire de Kansa en Suède.

2. La défense d'importation de Port Saïd de chiffons, de ouate ayant déjà servi, de bourré de laine, de déchet de papier, de poils, de peaux, de vieux sacs, de tapis, de broderies, de déchets, d'animaux frais, de sabots, de soie ecrue, de laine, en outre de linge sale, d'effets d'habillement et d'objets de literie à moins que ces objets ne fassent partie des bagages de voyageurs. La linge, les effets d'habillement et les objets de literie importés comme bagages seront désinfectés sous contrôle.
