The Official Gazette of the 30th instant publishes a Ministerial Decree on the subject to the following effect :-- "The extinction of the bubonic plague in Glasgow having been officially confirmed, the Imperial and Royal Government has seen fit to repeal the regulations contained in the Ministerial Decree of September 27th last, prohibiting the importation into or transit through Austria-Hungary of certain articles proceeding from Glasgow. Further, inasmuch as the plague no longer exists in Great Britain, direct arrivals from that country will no longer be subjected to the medical inspection prescribed by the Minis-terial Decree of September 3rd last."

The Decree takes effect from the day on which it is made known to the Imperial Customs and Sanitary Authorities.
