GENERAL ORDER of the Local Government Board: Suspension in part of General Consolidated Order: Medical Officers' Fees:—

Kendal Union.

To the Guardians of the Poor of the Kendal Union;

And to all others whom it may concern.

WHEREAS by a General Order of the Poor Law Commissioners bearing date the twenty-fourth day of July, one thousand eight hundred and forty-seven, which is in force in the Kendal Union, certain rules and regulations were made relating to the administration of relief to the poor: and by Articles 177 to 183 (inclusive) of the said Order provision was made for the payment of special fees to Medical Officers in certain cases;

And whereas it is expedient to suspend, as hereinafter mentioned, the operation of the said Articles as regards the Medical Officer for the Kendal District and the Workhouse of the said Union:
