1. THE Lords Commissioners of His Majesty's
Treasury hereby give notice that Tenders will be
received at the Chief Cashier's Office, at the Bank
of England, on Monday, the 25th instant, at one
o'clock, for Treasury Bills to be issued under
the Acts 40 Vic., cap. 2, and 52 Vic., cap. 6, to
the amount of £2,720,000, for the replacement of
£1,000,000 falling due on the 25th instant, and
£1,720,000 falling due on the 30th instant.

2. The Bills will be in amounts of £1,000,
£5,000, or £10,000. They will be dated the
30th March, 1901, and will be payable at twelve
months after date, viz. :—on the 30th March,
1902.

be made through a London Banker.*

Bank of England.

26th instant, and payment in full of the amounts
of the accepted Tenders must be made to the
Bank of England not later than one o'clock, on
Saturday, the 30th instant.

ORDER of the Local Government Board :
Altering Name of Union :—

New Winchester (Winchester) Union.

To the Guardians of the Poor of the New
Winchester Union ;—

To the Overseers of the Poor of the several
Parishes comprised in the said Union ;—

And to all others whom it may concern.

WHEREAS by section 13 of "The Divided
Parishes and Poor Law Amendment Act, 1876,"
it is enacted as follows :—

"The Local Government Board may, when
"they see fit, by their Order change the
"name of any Union, and direct how such
"change of name shall be published; no
"such change of name shall affect any rights
"or obligations of, or securities given by or
"to, the said Union, or render defective any
"legal proceedings instituted by or against
"the said Union; and any legal proceedings
"may be continued or commenced by or
"against the said Union by their new name
"which might have been continued or com-
"menced by or against the Union by their
"former name."

And whereas by an Order dated the 24th day
of July, 1835, the Poor Law Commissioners
declared that the several Parishes and Places
