ORDER OF THE BOARD OF AGRICULTURE.

(DATED 25TH MARCH 1901.)

FOREIGN ANIMALS (AMENDMENT) ORDER OF 1901.

THE Board of Agriculture, by virtue and in exercise of the powers in them vested under the Diseases of Animals Acts, 1894 and 1896, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows :

Animals from the Republic of Chile Prohibited.

1. Unless and until the Board otherwise order, it shall not be lawful to land any animal brought from the country of the Republic of Chile, and the First Schedule (*Prohibited Countries and Parts* of *Countries*) to the Foreign Animals Order of 1896 shall be read and have effect as if that country were included in the list of prohibited countries and parts of countries mentioned in that Schedule.

Interpretation.

2. In this Order terms have the same meaning as in the Foreign Animals Order of 1896.

Commencement.

3. This Order shall come into operation on the first day of May, one thousand nine hundred and one.

Short Title.

4. This Order may be cited as the FOREIGN ANIMALS (AMENDMENT) ORDER OF 1901.
