Ecclesall Bierlow Union.

To the Guardians of the Poor of the Ecclesall Bierlow Union ;-

And to all others whom it may concern.

WHEREAS the Poor Law Commissioners, by a General Order bearing date the twentyfourth day of July, one thousand eight hundred and forty-seven, made certain rules and regulations relating to the administration of relief to the Poor within certain Unions, including the said Ecclesall Bierlow Union; and by Article 182 of the said Order provision was made for the payment of special fees to Medical Officers in certain cases ;

And whereas it is expedient to suspend, as hereinafter mentioned, the operation of the said Article as regards the Resident Medical Officer for the Workhouse of the said Ecclesall Bierlow Union :

Now therefore, We, the Local Government Board, in pursuance of the powers given to Us by the Statutes in that behalf, hereby suspend the operation, until We by Order shall otherwise direct, of Article 182 of the above-cited Order with respect to the Resident Medical Officer for the time being for the Workhouse of the said Ecclesall Bierlow Union.
