**RESTRICTED OCCUPATIONS ORDER.**

**ORDER OF THE MINISTER OF MUNITIONS UNDER THE DEFENCE OF THE REALM REGULATIONS RELATING TO RESTRICTED OCCUPATIONS.**

Whereas by Regulation 8A of the Defence of the Realm Regulations the Minister of Munitions has power, amongst other things, to regulate or restrict the carrying on of any work in any factory, workshop, or other premises, or the engagement or employment of any workmen or all or any classes of workmen therein, with a view to maintaining or increasing the production of munitions in other factories, workshops, or premises:

Now, therefore, in pursuance of his power under that regulation and of all other powers enabling him in that behalf, the Minister of Munitions, at the request of the Director-General of National Service, hereby orders that, in connection with the industries and occupations mentioned in the Schedule to this order, the carrying on of work in factories, workshops, or other premises, and the engagement or employment of workmen, or all or any classes of workmen therein, is hereby regulated and restricted, as follows:—

1. After the date of this order, the occupier of a factory, workshop or other premises shall not, except as herein provided, take or transfer into employment in any industry or occupation mentioned in the Schedule to this order, whether to fill a vacancy or otherwise, any man who has attained the age of 18 and has not attained the age of 61, whether the man has previously been so employed or not:

Provided that nothing in this order shall prevent—

(a) the occupier of any factory, workshop, or premises from taking or transferring men into his employment with the consent of the Director-General of National Service given on the ground that the employment is expedient for the purpose of executing a Government contract, or on the ground that the work on which the men are to be em-
