GENERAL ORDER (FURTHER AMENDMENT) OF THE CENTRAL CONTROL BOARD (LIQUOB TRAFFIC).

We the Central Control Board (Liquor Traffic) in pursuance of the powers conferred upon us by the Acts and Regulations relating to the Defence of the Realm hereby make the following Order:

1. This Order shall apply to all Areas to which the Defence of the Realm (Liquor Regulations, 1915, have been Control) applied.

2. The Article entitled "Treating pro-hibited " in each of the Orders of the Board now in force in the said Areas is hereby revoked and shall cease to have effect.
