In pursuance of the powers conferred on him by the Trade Boards Acts, 1909 and 1918, the Minister of Labour is pleased to establish a Trade Board for the Toy Trade in Great Britain, as specified in the Trade Boards (Toy) Order, 1920, namely:—

The Toy Trade, that is to say, the manufacture of articles intended for the amusement of children, including dolls, metal, wooden or other hard toys, soft toys, books made from textile material, requisites for table games, bricks, blocks, puzzles, balls, Christmas crackers, Easter eggs, masks or drums, including also:—

(a) The assembling of parts of any of the above-mentioned articles.

(b) The operations of storing, boxing, packeting, labelling or dispatching, and all other warehousing or packing operations incidental to the manufacture of any of the above-mentioned articles,

but excluding:—

(a) The manufacture of toys when carried on as a subsidiary branch of work in asso-
