RUGBY URBAN DISTRICT COUNCIL.

NOTICE is hereby given, that the Rugby Urban District Council (hereinafter called "the Council") intend to apply to Parliament in the ensuing Session for leave to bring in a Bill (hereinafter called "the Bill") for effecting all or some of the following among other purposes (that is to say):—

To authorize the Council to make and maintain new waterworks consisting of the following:—

(1) An impounding reservoir capable of holding 250 million gallons of water and situate in the parishes of South Kilworth and Westrill and Starmore, in the rural district of Lutterworth, in the county of Leicester, and the parish of Welford, in the rural district of Oxendon, and the parish of Stanford, in the rural district of Crick, both in the county of Northampton, to be formed by a dam in the said parishes of South Kilworth, Stanford and Westrill and Starmore 13.25 chains in length across the River Avon at a point about 5 chains eastwards of the eastern end of Horse Shoe Spinney and extending up the valley of the Avon to a point about 5.50 chains north-east of the road leading from South Kilworth to Northampton.

(2) An alteration in the parishes of South Kilworth, Stanford and Welford of the level of the public road leading from South Kilworth to Northampton where such road crosses the River Avon.

(3) A line of pipes from the intended reservoir to the existing suction well belonging to the Council in the parish of Brownsover in the rural district of Rugby, in the county of Warwick, such line of pipes being situate in or passing through the parishes of South Kilworth, Westrill and Starmore, Swinford and Catthorpe in the said rural district of Lutterworth and in the parishes of Stanford and Lilbourne in the rural district of Crick, in the county of Northampton, and in the parishes of Newton and Biggin, Clifton-upon-Dunsmore and Brownsover in the rural district of Rugby and in the parish and urban district of Rugby, all in the county of Warwick.

(4) A road in the said parish of South Kilworth leading to the River Avon below the intended reservoir, and

(5) A recording station in the parish of Husband Bosworth in the rural district of Market Harborough, in the county of Leicester.

To authorize the Council to make and maintain certain sewerage works consisting of four sewers and sewage purification works in the parish of South Kilworth, the purification works being situate in the inclosure No. 60 on the ¹/₂₅₀₀ Ordnance Map Northamptonshire, Sheet LXXII. 7, Leicestershire Sheet LIII. 7 (Second Edition 1900), and a pumping station, three sewers and an accommodation road and sewage purification works in the parish of

Welford, the purification works being situate in the inclosure Nos. 269 on the ¹/₂₅₀₀ Ordnance Map Northamptonshire, Sheet XXIII. 5, and Leicestershire, Sheet LIV. 5.

To authorize the acquisition compulsorily or by agreement of lands in the parishes aforesaid for the purposes of the intended works, and the acquisition compulsorily or by agreement of easements only in or over lands.

To authorize the taking of the water of the River Avon; to make provisions as to the purification and disposal of the sewage intercepted by the intended sewerage works; to enable the Council to discharge sewage effluent into the Avon; to divert existing sewers and drains; to prohibit the opening into the Avon above the intended reservoir of sewers and drains and the discharge of sewage or casting of rubbish.

To authorize agreements between the Council and the Lutterworth Rural District Council and the Oxendon Rural District Council in regard to the intended sewerage works and other matters; Subsidiary works; Deviation: Provisions for protection of water against pollution and in regard to sale and retention of lands; Agreements with Rugby Rural District Council and other authorities for supply of water in bulk; Increase of water rates; Further powers with regard to the supply of water; Further powers in regard to the electricity undertaking of the Council and the supply of electricity; Further powers in regard to the letting and use of public baths; Pleasure grounds; Further powers with regard to streets and buildings, watercourses, sewers, drains, etc.; Provisions as to infectious disease and sanitary matters and human food; Hackney carriages; Police matters; Slaughterhouses; Verminous houses and persons; Offensive trades; Additional borrowing powers and financial provisions; Consolidation of rates; Bye-laws; Street cries; Miscellaneous and incidental provisions; Incorporation repeal and amendment of Acts.

Duplicate plans and sections showing the lines, situation and levels of the proposed works and the lands, houses and other property in or through which they will be made, and also duplicate plans showing the lands, houses and other property intended to be compulsorily taken or used for other purposes under the powers of the Bill, together with a book of reference to such plans, containing the names of the owners and lessees, or reputed owners and lessees, and of the occupiers of such lands, houses and other property, will, on or before the 30th day of November instant, be deposited for public inspection with the Clerk of the Peace for the County of Leicester at his office at Leicester, with the Clerk of the Peace for the County of Northampton at his office at Northampton, and with the Clerk of the Peace for the County of Warwick at his office at Leamington, and on or before the same date a copy of so much of the said plans, sections and book of reference as relates to each of the areas hereinafter mentioned, in or through which the said works, or any part thereof, are or is intended to be made, or are or will be situate, or in which any lands to be taken compulsorily under the powers of the Bill are situate, will be deposited for public inspection as follows (that is to say):—
