To extend the time for the construction of the tramways authorized by the Stalybridge, Hyde, Mossley and Dukinfield Tramways and Electricity Board Act, 1915 (hereinafter referred to as "the Act of 1915"); to increase the tolls, fares and charges upon the existing and authorized tramways of the Board, and to empower the Board to provide and run motor omnibuses in the boroughs of Stalybridge, Hyde, Mossley and Dukinfield and outside the boroughs along the routes of the tramways authorized by the Act of 1915, and also along certain additional routes in the urban district of Saddleworth, in the West Riding of the County of York, and the urban districts of Hollingworth and Mottram-in-Longdendale, and the parish of Tintwistle, in the rural district of Tintwistle, all in the county of Chester.

To make provision in regard to the tolls, fares and charges in respect of the use of the omnibuses and further provisions in regard to the omnibuses and the tramway and electricity undertakings of the Board.

To authorize the Board to borrow further moneys, and to make further provisions in regard to the finances of the Board; extension of provisions of existing Acts; miscellaneous and incidental provisions; incorporation, repeal and amendment of Acts.

prescribed by the Bill; Adaptation of roads; Fares and charges for and generally as to working and user of omnibuses; Working agreements re omnibuses; Continuance and maintenance of gas undertaking; Existing and new gas lands; Provisions as to supply of gas and charges therefor; Calorific value and pressure; Continuance and maintenance of electricity undertaking; Lands for generating stations; Provisions as to supply of electricity and charges therefor; Continuance and maintenance of markets undertaking; Amendment and revision of tolls, rates and charges; Provisions as to public buildings, libraries and baths; Acquisition of lands for purposes of marine gardens, parks and pleasure grounds; Management and control; Charges for admission; Letting and use for recreation and other purposes; Sea defence works; Marine lake; Sea-water supply; Removal of sand, etc., from seashore; Provisions as to seashore, beach, esplanades, parks, entertainments, bathing, recreation, etc.; Golf courses; Acquisition of land; Retention and sale of land; Building regulations; Provisions as to streets and development of estates and property; Sewers and drains; Undertakings, etc., to bind successive owners; Streams and watercourses; Fire prevention and precautions; Regulation of hoardings; Milk supply and tuberculosis; Provisions in regard to infectious disease and sanitary matters; Hackney carriages; Routes for motor omnibuses; Police provisions; Distribution of handbills; Touting; Consolidation and amalgamation of parishes of Lytham and St. Annes on the Sea; Appointment of overseers; Consolidation of rates; Differential rating; Borrowing powers; Sinking funds; Revenue and expenditure on undertakings; Financial provisions; Application of funds, rates and revenues; Byelaws and regulations; Penalties; Entry and inspection; Agreements; Tolls, rents, rates and charges and alteration thereof; Repeal, amendment and incorporation of Acts.
