WEYMOUTH AND MELCOMBE REGIS ELECTRICITY
 (EXTENSION) SPECIAL ORDER, 1927.

NOTICE is hereby given that the Electricity
 Commissioners have submitted to the
 Minister of Transport for confirmation under
 the above-mentioned Acts a Special Order
 made by them for the supply by the Mayor
 Aldermen and Burgesses of the Borough of
 Weymouth and Melcombe Regis of electricity
 within the Rural District of Weymouth and
 parts of the Rural Districts of Dorchester and
 Wareham and Purbeck in the County of
 Dorset.

The Minister of Transport proposes to con-
 firm the Order and gives notice that any
 person affected who may be desirous of
 objecting to the confirmation of the same must
 in accordance with the Electricity (Confirma-
 tion of Special Orders) Rules, 1921, do so by
 memorial addressed to the Minister of Trans-
 port written on one side only of foolscap paper
 and sent by registered post addressed to the
 Secretary, Ministry of Transport, 6, Whitehall
 Gardens, London, S.W. 1, and posted not
 later than the 26th day of November 1927.
 A copy of any such memorial must also be
 sent in like manner to Percy Smallman, Esq.,
 Town Clerk, Municipal Offices, Weymouth, or
 to Messrs. Dyson, Bell and Company, 19,
 Abingdon Street, Westminster, London,
 S.W. 1, Parliamentary Agents for the Order.
 Such memorial must be sealed or signed by
 the person objecting or by some responsible
 and duly authorised person on his behalf and
 must state the specific grounds of objection to
 the Order and the modifications desired.
