#### SCHEDULE.

Clause 74 of the Kent District (Coal Mines) Scheme, 1930, shall be amended as follows:—

The words "The President for the time being of the Institute of Chartered Accountants shall be requested to furnish a list of independent Arbitrators from whom the Board shall prepare a panel of not less than five Arbitrators for the District," at the beginning of the Clause shall be deleted and there shall be substituted therefor the following words: "There shall be a panel of not less than five Arbitrators for the District. For the purpose of constituting such panel and filling vacancies therein the Board shall prepare from time to time in accordance with a unanimous resolution of the Board a list of nominees for service on the panel. All such nominations shall be submitted to and approved by one of the following persons, viz.: The President for the time being of the Institute of Chartered Accountants, the President for the time being of The Law Society, and the President for the time being of the Institute of Civil Engineers. The Board may at any time and shall (if the Board shall fail to prepare in manner aforesaid before the 20th day of April, 1931, a list of a sufficient number of nominees to constitute the panel or shall fail to nominate substitutes to fill any vacancies therein within one calendar month after such vacancies shall have occurred) request any one or more of the persons hereinbefore named to furnish a list of independent arbitrators from whom the Board may by ordinary resolution make appointments for the purpose of constituting or completing the panel and thereupon the nominees (if any) nominated by unanimous resolution of the Board and approved as aforesaid and the independent arbitrators included in the said list and appointed by ordinary resolution of the Board shall together constitute the panel."
