

" Whereas by the authority of an Order of Her said late Majesty in Council bearing date the 30th day of January, 1854, and published in the London Gazette on the 31st day of the same month, a Consolidated Chapelry was assigned to the consecrated Church situate at Sandgate, in the Parish of Folkestone, in the said County and Diocese, and the said Consolidated Chapelry was named 'The Consolidated Chapelry of Sandgate':

" And whereas by the authority of an Instrument bearing date the 6th day of August, 1868, and being under our Common Seal and under the hand and seal of the Right Honourable and Most Reverend Charles Thomas, then Archbishop of Canterbury, part of the New Parish of Christ Church, Folkestone, in the said County and Diocese, was assigned as a Particular District to the consecrated Church of the Holy Trinity, Folkestone:

" And whereas the said Consolidated Chapelry of Sandgate and the said Particular District of the Holy Trinity, Folkestone, have under the provisions of the Act of the 19th and 20th years of Her said late Majesty, Chapter 104, become New Parishes of the character contemplated by that Act, by the Act of the 6th and 7th years of Her said late Majesty, Chapter 37, and by the above mentioned Act of the 32nd and 33rd years of Her said late Majesty, Chapter 94:

" And whereas it has been represented to us, and it appears to us to be expedient that the boundaries of the said New Parish of Sandgate and of the said New Parish of the Holy Trinity, Folkestone, should be altered in the manner which is hereinafter mentioned:

" Now, therefore, with the consent of the Right Honourable and Most Reverend Cosmo Gordon, Archbishop of Canterbury (in testimony whereof he has signed and sealed this Scheme or Representation), we, the said Ecclesiastical Commissioners, humbly represent recommend and propose that from and after the day of the date of the publication in the London Gazette of an Order of Your Majesty in Council ratifying this Scheme or Representation and without any assurance in the law other than such duly gazetted Order the boundaries of the said New Parish of Sandgate and of the said New Parish of the Holy Trinity, Folkestone, shall be altered so that all those portions of the said New Parish of Sandgate and of the Parish of Cheriton, in the said County and Diocese, which are described in the Schedule hereunder written and are delineated and set forth upon the map or plan hereunto annexed and are thereon coloured pink shall be dissevered from such New Parish and Parish respectively and shall be annexed to and shall in future form part of the said New Parish of the Holy Trinity, Folkestone.

" And we further represent, recommend and propose that nothing herein contained shall prevent us from representing, recommending and proposing any other measures relating to the matters aforesaid or any of them in accordance with the provisions of the hereinbefore mentioned Acts or of any of them or of any other Act of Parliament.

" THE SCHEDULE to which the foregoing Scheme or Representation has reference.

" The territory to be annexed to the New Parish of the Holy Trinity, Folkestone, in the

County of Kent and in the Diocese of Canterbury, comprising:—

" All those contiguous portions of the New Parish (sometime Consolidated Chapelry) of Sandgate and of the Parish of Cheriton, both in the said County and Diocese, which taken together are bounded upon the north partly by the New Parish of All Souls, Cheriton Street, and partly by an isolated portion of the Parish of Folkestone, both in the said County and Diocese, upon the east by the said New Parish of the Holy Trinity, Folkestone, and upon the remaining sides, that is to say, upon the south and upon the west, by an imaginary line commencing at the point at the top of Radnor Cliff where the boundary which divides the said New Parish of the Holy Trinity, Folkestone, from the said New Parish of Sandgate is crossed by the boundary of the Urban District of Sandgate, and extending thence westward along the said Urban District boundary (thereby following for the most part the top of Radnor Cliff) for a distance of 20½ chains or thereabouts to the point where it crosses the middle of Radnor Cliff Crescent, and extending thence first northward and then north-eastward along the middle of Radnor Cliff Crescent for a distance of 12 chains or thereabouts to its junction with Sandgate Hill and Coolinge Lane, and extending thence first north-westward and then northward along the middle of Coolinge Lane for a distance of 15½ chains or thereabouts to a point opposite to the eastern end of the fence which divides the close numbered 18d upon the Ordnance Survey Map of the Civil Parish of Folkestone next Sandgate published in the year 1933 on the scale of 25 inches to a mile and also upon the map or plan annexed to this Scheme or Representation from the close numbered 19 upon the said maps, and extending thence first westward to such fence and then first westward and then in various directions along the fences which divide the said close numbered 18d and the closes numbered 18e, 18, 22, 20a and 20 upon the said maps from the said close numbered 19 and the closes numbered 19a, 12 and 11 upon the same maps for a distance of 22 chains or thereabouts to the point where the fence which divides the said close numbered 20 from the said close numbered 11 reaches the boundary which divides the said New Parish of Sandgate from the said Parish of Cheriton, and extending thence generally northward along the last mentioned boundary for a distance of 26 chains or thereabouts to the point where it is crossed by the wall or fence forming the southern boundary of certain houses and premises situate on the southern side of Shorncliffe Crescent, and extending thence first westward along such wall or fence and then northward along the wall or fence forming the western boundary of certain other houses and premises situate on the western side of Shorncliffe Crescent for a distance in all of 15 chains or thereabouts to the point where the last mentioned wall or fence reaches the southern side of Shorncliffe Road, and extending thence northward across Shorncliffe Road for a distance of 14 yards or thereabouts to the southern end of the wall or fence forming the western boundary of the house and premises known as Number 218 Shorncliffe Road, and extending thence north-eastward along such wall or fence and in a straight line in continuation thereof for a distance of 4
