

financial position appears to them to require it, to remit from time to time any part of the annual sum of one hundred guineas or such other sum as may be payable as aforesaid. The Warden and Fellows shall determine the scale upon which such remission shall be made and the method by which the need of each Scholar shall be ascertained.

2. This Statute shall, as regards Scholars to whom it shall apply, be substituted for Section 10 of Statute XI and Section 2 of Statute XII of the Statutes of Winchester College approved by His late Majesty King Edward the Seventh in Council on the 24th day of October, 1904, as amended and further amended by Statutes approved by His late Majesty King George the Fifth in Council on the 26th day of April, 1920, and by His Majesty the King in Council on the 22nd day of February, 1940.

3. This Statute shall not apply to Scholars admitted or elected at any time before the approval of this Statute by His Majesty the King in Council or before the election of 1943, whichever shall be the later event. For such Scholars the above mentioned Sections, amended and further amended as aforesaid, shall remain in force.

4. This Statute shall come into force and commence immediately upon the approval thereof by His Majesty the King in Council.

II.

A Statute for further amending Statutes of the College concerning Competitive Exhibitions.

1. Exhibitions hereafter to be offered under Section 1 of Statute XII of the Statutes of Winchester College approved by His late Majesty King Edward the Seventh in Council on the 24th day of October, 1904, as amended by a Statute of the College approved by His late Majesty King George the Fifth in Council on the 14th day of October, 1941, shall be of such number in each year and of such value in each case as the Warden and Fellows may from time to time determine, having regard to the income of the College at their disposal.

2. Subject as aforesaid, all the provisions of Section 1 of the said Statute as so amended shall apply to such Exhibitions.

3. This Statute shall come into force and commence immediately upon the approval thereof by His Majesty the King in Council.

III.

A Statute to provide Bursaries for boys not on the foundation of the College.

1. The Warden and Fellows may award non-competitive Exhibitions called Bursaries to be held by boys in the School other than Scholars who by reason of their financial position are in the opinion of the Warden and Fellows unable to pay the full School fees.

2. The said Bursaries shall be of such amount, not exceeding one hundred pounds per annum, as the Warden and Fellows shall in each case determine, and shall be tenable for such period and subject to such terms and conditions as they shall direct.

3. The said Bursaries shall be of such number as the Warden and Fellows shall from time to time determine, having regard to the income of the College at their disposal and the remission of fees to Scholars and the provision of competitive Exhibitions.

4. The said Bursaries may be awarded to boys already in the School or to boys of a suitable standard, not yet in the School, to be held by them upon entering.

5. This Statute shall come into force and commence immediately upon the approval thereof by His Majesty the King in Council.

TENDERS FOR TREASURY BILLS.

1. The Lords Commissioners of His Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank

of England, on Friday, the 20th February, 1942, at 1 p.m., for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the National Loans Acts, 1939 to 1941, to the amount of £75,000,000.

2. The Bills will be in amounts of £5,000, £10,000, £50,000 or £100,000. They will be dated at the option of the tenderer on any business day from Monday, the 23rd February, 1942, to Saturday, the 28th February, 1942, inclusive, and will be payable at three months after date.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000, and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

6. The persons whose Tenders are accepted will be informed of the same not later than the following day, and payment in full of the amounts of the accepted Tenders must be made to the Bank of England by means of Cash or a Banker's Draft on the Bank of England not later than 1.30 p.m. (Saturday 12 noon) on the day on which the relative Bills are to be dated.

7. Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

9. The Lords Commissioners of His Majesty's Treasury reserve the right of rejecting any Tenders.
