HOMICIDE ACT, 1957

An Inquisition indented, taken for our Sovereign Lady the Queen, at H.M. Prison, Wandsworth, pursuant to the directions of "The Capital Punishment Amendment Act, 1868," on the twenty-fifth day of May, in the year of our Lord one thousand nine hundred and sixty-one, before Gavin Leonard Bourdas Thurston, Coroner of our said Lady the Queen for the said County of London, on view of the body of Victor John Terry now here lying dead at Her Majesty's Prison, Wandsworth, within the Jurisdiction of the said Coroner, upon the oaths of the undersigned Jurors, good and lawful men of the said signed Jurors, good and lawful men of the said signed Jurors, good and lawful men of the said County of London, who being now here duly chosen, sworn, and charged to enquire, for our said Lady the Queen, when, where, and in what manner, the said Victor John Terry came to his death, say upon their oaths that the said Victor John Terry was a Prisoner in the said Prison, indicted and convicted for the murder of John Henry Pull and sentenced to death for the said offence, after the passing of the said Statute. And that judgment of death was duly said Statute.
