PASTORAL MEASURE 1968

Notice is hereby given that Her Majesty was pleased on 30th July 1982 by Order in Council to confirm the following Schemes made by the Church Commissioners for:

1. Uniting the benefices of Wolverley; and St. Peter, Cookley, in the diocese of Worcester.
2. Declaring redundant the church of St. Bartholomew, Richard's Castle, in the diocese of Hereford.
3. Uniting the benefices of Bath, Odd Down; and Combe Hay, in the diocese of Bath and Wells.
4. Uniting the benefices of Amcotts with Luddington and Garthorpe; and Althorpe, in the diocese of Lincoln.
5. Creating a new parish of St. Mary, Walton-in-Gordano; East Clevedon; Weston-in-Gordano and Christ with Portbury and Clapton-in-Gordano; Walton-in-Gordano; East Clevedon; Weston-in-Gordano and Christ Church, Pill, in the diocese of Bath and Wells.
6. Uniting the benefices of Kibworth Beauchamp and Smeeton Westerby with Saddington, in the diocese of Leicester.
7. Uniting the benefices of St. Thomas, Trowbridge and St. John, West Ashton, in the diocese of Salisbury and including the new benefice in a group ministry established by an earlier Scheme.
8. Declaring redundant the parish church of Attercliffe, in the diocese of Sheffield.
9. Dissolving the benefice of Thurnham with Detling, in the diocese of Canterbury, and transferring its constituent parishes to other benefices.
10. Uniting the benefices and parishes of St. Paul, Lozells, and St. Silas, Lozells, in the diocese of Birmingham and declaring redundant the parish church of St. Paul, Lozells.
11. Appropriating part of the churchyard of the parish church of Stockton-on-Tees with St. John the Baptist, Stockton, in the diocese of Durham, for use as a site for a parsonage.
12. Uniting the benefices of Buxted; St. Mary, Buxted; and St. Mark, Hadlow Down, in the diocese of Chichester.
13. Declaring redundant the church of St. Jude, Milton, in the diocese of Bath and Wells.
14. Uniting the benefices of Churchstanton with Otterford; and Buckland St. Mary, in the diocese of Bath and Wells.
15. Uniting the benefices of Week St. Mary; Roundstock; and Whitstone, in the diocese of Truro.
16. Uniting the benefices of St. John the Evangelist, Hurst Green; and Mitton, in the diocese of Bradford.
17. (1) Altering the areas of the parishes of Bristol, St. Jude with St. Matthias; and Bristol, St. Philip and St. Jacob with Emmanuel;
 - (2) uniting the benefices and parishes of Holy Trinity with St. Gabriel and St. Lawrence, Easton; and Bristol, St. Jude with St. Matthias; and
 - (3) declaring redundant the parish church of Bristol, St. Jude with St. Matthias, in the diocese of Bristol.
18. Establishing a group ministry for the benefices of All Saints, Bromsgrove; Catskill and Dodford; and St. Godwald, Finstall, in the diocese of Worcester.
19. Uniting the benefices of Kirkby Malzeard with Dallaghill; Grewelthorpe; and Mickley, in the diocese of Ripon.
20. Uniting the benefices of Crediton; and Shobrooke; and establishing a group ministry for the new benefice and the benefice of Sandford with Upton Hellions, in the diocese of Exeter.
21. Uniting the benefices of Heydon with Little Chishill; and Great Chishill, in the diocese of Chelmsford.
22. Uniting the benefices of Brothertoft; and Holland Fen, in the diocese of Lincoln.
23. Dissolving the parish of Wincle and Wildboardclough and creating new parishes of Wincle St. Michael; Wildboardclough St. Saviour, in the diocese of Chester.
24. Re-arranging the benefices of Reymerston; Cranworth with Letton and Southbergh; and Whinburgh with Westfield and their constituent parishes, in the diocese of Norwich.
25. Vesting part of the churchyard of the parish church of Aspatria, in the diocese of Carlisle, in the Diocesan Board of Finance, for disposal.
26. Vesting a burial ground in the parish of Rustington, in the diocese of Chichester, in the Diocesan Board of Finance, for disposal.
27. The care and maintenance of the tower of the redundant church of St. Thomas a Becket, Pensford, in the diocese of Bath and Wells.
28. Appropriating the redundant church of St. John, Little Ouse, in the diocese of Ely, and the annexed land for sale for residential and ancillary purposes.
29. Demolishing the redundant church of St. John, Highbury Vale, in the diocese of London, and authorising the disposal of its site and annexed land.
30. Authorising the gift of part of the site and annexed land of the former church of St. Paul Milton Regis, in the diocese of Canterbury.
