TOWN AND COUNTRY PLANNING ACT 1990

Stopping-up of an Area of Elmbank Road, Paignton

The Secretary of State for Transport hereby gives notice that he has made an Order under section 247 of the above Act entitled "The Stopping-up of Highways (County of Devon) (No. SW 4) Order 1992" authorising the stopping-up of an area of Elmbank Road, Paignton, Devon, to enable development to be carried out in accordance with planning permission granted under Part III of that Act and requiring the improvement of the highway.
