#### Monopolies and Mergers Commission Report on the Supply of National Newspapers in England and Wales

This notice concerns an Order the Secretary of State for Trade and Industry intends to make in relation to the wholesale supply of national newspapers to retailers in England and Wales. Before he makes the Order he is required, under section 91(2) of the Fair Trading Act 1973 ("the Act"), to publish a notice so that anyone with an interest in the matter may make representations to him.

- 1. The Monopolies and Mergers Commission's report: "The supply of national newspapers in England and Wales" ("the Report") was presented to Parliament by the Secretary of State for Trade and Industry by command of Her Majesty and published in December 1993 (Cm. 2422). Copies of the report may be obtained from Her Majesty's Stationery Office.
- 2. The MMC identified two practices as being against the public interest. First the refusal by wholesalers to supply new outlets on the grounds that the area was already adequately served with newspapers supplies; and secondly the requirement that newspapers be sold only from designated premises.
- 3. The Secretary of State intends to make an Order under sections 56(2) and 90(2) and (4) of, and paragraphs 1, 2, 4, 6 and 12A of Schedule 8 to the Act for the puposes of remedying or preventing the adverse affects specified in the Report.

#### The nature of the proposed provisions

- 4. The Order will make provision about the supply by newspaper wholesalers of national newspapers to retailers in England and Wales. The following paragraphs set out the nature of the terms to be included in the Order. This is subject to the Secretary of State considering any representations he receives.
- 5. It will be unlawful for a newspaper wholesaler to withhold or threaten to withhold any supplies of a national newspaper from a retailer unless:
  - (a) there are commercial grounds for not supplying that retailer such as that the Order is below a minimum size or the retailer is not creditworthy (but not that the area in which the retailer is situated is already adequately served by other retailers with that national newspaper);
  - (b) the retailer is not within the territory which that wholesaler serves with that newspaper.
- 6. The Order will make it unlawful for a newspaper wholesaler to make or carry out an agreement:

- (a) which specifies or restricts the place at which a retailer to whom the wholesaler supplies national mewspapers may sell those Newspapers;
- (b) which restricts a retailer to whom the wholesaler supplies national newspapers from disposing of those newspapers other than by way of retail sale.
- 7. The Order will require newspaper wholesalers to terminate any exising agreement to the extent that it contains provisions of the kind mentioned in the previous paragraph.
- 8. The Order will require newspaper wholesalers to provide the Director General of Fair Trading with information about the numbers of occasions on which supplies of national newspapers have been refused and the reasons for the refusal.
- 9. The Order will make it unlawful for a newspaper wholesaler to discriminate in the prices to be charged to retailers or prospective retailers for the supply of national newspapers.
- 10. A number of terms will be defined in the Order, in particular:
  - (a) National newspaper will include all newspapers with a significant circulation throughout England and Wales;
  - (b) Retailer will include prospective retailer.
