HIGHWAYS ACT 1980

*The Chester-Holyhead Trunk Road (A55) (Llanfair Pwllgwyngyll to Bryngwran Side Roads) Order 1996*

The Secretary of State for Wales hereby gives notice that, in relation to the new Trunk Road to be constructed by him from Llanfair Pwllgwyngyll to Bryngwran in the Isle of Anglesey County, he has made under sections 12, 14 and 125 of the Highways Act 1980, an Order, the effect of which is:

(a) to authorise him:

- (i) to carry out the improvement of highways;
- (ii) to stop up highways;
- (iii) to construct new highways;
- (iv) to stop up private means of access to premises; and
- (v) to provide new means of access to premises,

all on, or in the vicinity of the route of the above-mentioned new trunk road, and

(b) provide for the transfer of the said new highways to the Isle of Anglesey County Council as from the date on which he notifies the Council that the new highway has been completed and is open for through traffic.

Copies of the Order and of the relevant plan have been deposited at the offices of Gwynedd Council, Caernarfon, Gwynedd; The Library, Lon-y-Felin, Llangefni; The Post Office, Gaerwen, Anglesey; Holyhead Public Library, Newry Street, Holyhead; the Welsh Office, New Crown Buildings, Cathays Park, Cardiff, and the Welsh Office Highways Directorate, Government Buildings, Dinerth Road, Colwyn Bay, Clwyd, where they may be inspected, free of charge, at all reasonable hours.

Copies of the Order, the title of which is "The Chester-Holyhead Trunk Road (A55) (Llanfair Pwllgwyngyll to Bryngwran Side Roads) Order 1996", can be obtained from the Welsh Office Highways Directorate, RA3, Cathays Park, Cardiff.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the ground that any requirement of that Act, or of regulations made thereunder, has not been complied with in relation to the Order, may, within 6 weeks from 11th July 1996, or within the 6 weeks from the date of publication of this notice, if such period shall expire later, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.

### WILDLIFE AND COUNTRYSIDE ACT 1981

*Menai Strait Marine Nature Reserve Order 199*

Notice is hereby given that the Secretary of State for Wales, under the powers provided in section 36 of the Wildlife and Countryside Act 1981, proposes to make the Menai Strait Marine Nature Reserve Order 199.

The general effect of the Order, if made, will be that in respect of the area designated (which is described below) the Countryside Council for Wales will be responsible for the management of the Reserve, for the purpose of conserving marine flora and fauna and features of geological or physiographical interest, and for providing opportunities for their study under suitable conditions and control. This will mean that the area will be subject to certain prohibitions or restrictions specified in the relevant byelaws which are set out in the Order.

Representations about or objections to the Order may be made to the Secretary of State for Wales (Environment 4B), Welsh Office, Cathays Park, Cardiff CF1 3NQ, by 23rd August 1996. They should be in writing and should state the title of the Order and quote ref. cc 18-3-13. In the case of objections the grounds upon which they are made should also be stated.

Copies of the Order and the byelaws which have either been made or are proposed to be made for the protection of the area described below, together with a copy of the map which shows the area, have been deposited in the offices of Gwynedd Council, Shire Hall Street, Caernarfon, the Isle of Anglesey County Council, Council Offices, Llangefni and the Countryside Council for Wales, Bryn Menai, Upper Bangor, Gwynedd, and may be inspected free of charge. Copies thereof may be obtained at a reasonable charge, at all reasonable hours.
