Description of designated area

The description of the proposed Menai Strait Marine Nature Reserve is as follows:

The western boundary extends in a line on a true bearing of 314 degrees from the tumulus at Dinas Dinlle (53 degrees 4.9 feet north, 4 degrees 20-1 feet west) to meet at 53 degrees 8.95 feet north, 4 degrees 27 feet west another line drawn on a true bearing of 223 degrees from the headland of Pen y Parc (53 degrees 9-3 feet north, 4 degrees 26-5 feet west).

The eastern boundary extends in a line on a true bearing of 330 degrees from Penmaenmawr Point (53 degrees 16 feet north, 3 degrees 57 feet west) to a point off Ynys Seiriol (Puffin Island) at 53 degrees 19.6 feet north, 4 degrees 0.5 feet west, from whence it runs due west to meet a line drawn due north (true bearing) from a point 53 degrees 18.2 feet north, 4 degrees 9 feet west) in Traeth Coch (Red Wharf Bay).

Between these boundaries, the proposed reserve extends to mean high water on either shore, except between Y Felinheli (Port Dinorwic)/Moel y Don Slipway and the public slipway at Prince's Pier, Menai Bridge/the Telford Hotel, where it extends up to the Highest limit of astronomical tides on either shore; and where the proposed reserve abuts Newborough Warren—Ynys Llanddwyn National Nature Reserve, the boundary is the line of the mean low water mark.

The boundaries are also shown hatched in black on map 1 attached to the draft Order (Annex 1).

NOTICE OF SEIZURE UNDER THE CUSTOMS AND EXCISE MANAGEMENT ACT 1979

Under sections 139(1) and 139(6) of the Customs and Excise Management Act 1979 and paragraph 1 of Schedule 3 thereto, the Commissioners of Customs and Excise hereby give you notice that certain goods, namely:

One shaft
Associated bolts and washers
Various documents

have been seized as liable to forfeiture under section 68(1) of the Customs and Excise Management Act 1979.

If you claim that the goods are not liable to forfeiture, you must within one month of the date of this notice of seizure give written notice of your claim in accordance with paragraph 3 of Schedule 3 to the Customs and Excise Management Act 1979.
