

(M40/Ardley Interchange to B4031 Improvement) Side Roads Order 199 ;

- (ii) the execution of works on watercourses in connection with the construction of the new trunk road and the construction and improvement of other highways;
- (iii) use by the Secretary of State in connection with such construction and improvement of highways and the execution of other works mentioned above; and
- (iv) the mitigation of adverse effects with the existence or use of the new trunk road and other highways proposed to be constructed or improved will have on their surroundings.

Copies of the draft Compulsory Purchase Order and the plan referred to in paragraph 1, together with copies of the draft Order mentioned in paragraph 1(i) above with its accompanying plan, have been deposited and may be seen at all reasonable hours from 26th September 1996 to 17th October 1996 at the Highways Agency Room, 12/03 St. Christopher House, Southwark Street, London SE1 0TE, and at the offices of the Director, Highways Agency, Southern Operations Division, Room 414, Tollgate House, Houlton Street, Bristol BS2 9DJ; Oxfordshire County Council, Speedwell House, Speedwell Street, Oxford; Cherwell District Council, Bodicote House, Bodicote, Banbury, Oxfordshire; Bicester Public Library, Old Place Yard, Bicester, Oxfordshire; Brackley Public Library, Manor Road, Brackley, Northamptonshire.

Any objection to the draft Compulsory Order must be made in writing and addressed to the Secretary of State for Transport at the offices of the Director, Southern Operations Division, Highways Agency, Room 414, Tollgate House, Houlton Street, Bristol BS2 9DJ, not later than 17th October 1996, and should state the grounds of objection and quote reference PSE O/A43/2/65/9/3. In the preparation of an objection it should be borne in mind that the substance of any objection or representation may be communicated to other people who might be affected by it.

NOTE: (a) The land comprised in each item in this Schedule is identified on the plan referred to in the draft Compulsory Purchase Order by means of the number or numbers shown in brackets against that item in this Schedule, (b) reference to ownership are references to ownership or reputed ownership at the time of preparation of the draft Compulsory Purchase Order and are stated only for the purpose of identification of the land.

In the Parish of Stoke Lyne in the District of Cherwell

Half width of road known as The Length (1), (owned by Mr. J. Adams); half width of road known as The Length (2a), (owned by Tusmore Park Holdings SA); full width of road known as Tower Road; arable land forming part of Roundhill Farm north-west of A43 (3a and 3b) (owned by Mr. R. Browne).

In the Parish of Hardwick with Tusmore in the District of Cherwell

The right of lay and maintain a 300 millimetre diameter pipe with a 6 metre width, 230 metres long, and the right to construct and maintain access manholes and headwall, all in 1,380 square metres of woodland and arable land; the right to cleanse, widen and deepen 100 linear metres of watercourse in 600 square metres of arable land (2b and 2c) (owned by Tusmore Park Holdings SA); full width of road known as Pimlico Farm Road (4a) (owned by Mr. and Mrs. Harper); arable land forming part of Roundhill Farm north-west of A43 (3c) (owned by Mr. R. Browne).

In the Parish of Evenley in the District of South Northamptonshire

Full width of road known as Pimlico Farm Road (4b) (owned by Mr. and Mrs. Harper); pasture land south of White House Cottages and part of half width of Ockley Brook, all forming part of RAF Croughton north of the A43 trunk road (5) (owned by Secretary of State for Defence).
