#### TOWN AND COUNTRY PLANNING ACT 1990

*The Stopping-up and Diversion of Highways (Land situated between Uskmouth and Goldcliff, Newport) Order 1997*

The Secretary of State for Wales hereby gives notice that he has made an Order under section 247 of the Town and Country Planning Act 1990 to authorise the stopping-up and diversion of the lengths of highway described in Schedule 1 to this notice.

The stopping-up and diversions are authorised only in order to enable the development described in Schedule 2 to this notice to be carried out in accordance with planning permission granted by the Secretary of State for Wales on appeal on 14th November 1997 under references PP134-98-004 and PP134-98-005. The Order shall cease to have effect if its provisions have not been carried out before the cessation of the planning permission.

The Order requires the provision of new highways described in Schedule 1 to this notice which will be highway maintainable at public expense, for which Newport County Borough Council shall be the Highway Authority.
