THE BEXLEY BUS STOP CLEARWAY (NO STOPPING EXCEPT BUSES) (AMENDMENT NO) TRAFFIC ORDER 200
THE BEXLEY (WAITING AND LOADING RESTRICTION) (AMENDMENT NO) TRAFFIC ORDER 200

Notice is hereby given that Council of the London Borough of Bexley propose to make the above-mentioned Traffic Orders under sections 6 and 124, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984, as amended by section 8 of, and Part 1 of Schedule 9 to the Local Government Act 1985.

The Bexley Bus Stop Clearway (No Stopping Except Buses) (Amendment No) Traffic Order 200 would introduce "At any time" bus stop clearway restrictions at the Bus Stop in Woolwich Road, Abbey Wood outside Bexley College, in the London Borough of Bexley.

The Bexley (Waiting and Loading Restriction) (Amendment No) Traffic Order 200 would:

(a) introduce "At any time" waiting restrictions at the following junctions:

- (i) Highfield Road and Horsham Road, Bexleyheath;
- (ii) Oaklands Road and Martin Dene, Bexleyheath;
- (iii) Old Road and The Marlowes, Crayford;
- (iv) Woolwich Road and Heathview Road, Abbey Wood;
- (v) Westwood Lane and Northumberland Avenue, Welling; and in part of Woolwich Road, Abbey Wood outside Bexley College.

A copy of the Order, the Bexley Bus Stop Clearway (No Stopping Except Buses) Traffic Order 1997 (and the Orders that have amended that Order); the Bexley (Waiting and Loading Restriction) Order 1991, (and the Orders that have amended that Order); together with plans showing the length of road to which the Orders relate and the Council's statement of reasons for proposing to make the Orders can be inspected, during normal office hours on Mondays to Fridays inclusive until the expiration of a period of 21 days from the date on which this notice is published, at The Information Centre, Civic Offices, Bexleyheath, Kent, DA6 7LB.

PROPOSED WAITING AND LOADING RESTRICTIONS AT VARIOUS LOCATIONS AND REVOCATION OF A LENGTH OF WAITING RESTRICTION IN WADDON ROAD

Notice is hereby given that the Council of the London Borough of Croydon propose to make the Croydon (Waiting and Loading Restriction) (Amendment No. T26) Order 2001 under sections 6 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984, as amended by the Local Government Act 1985.

2. The general effect of the Order would be to further amend the Croydon (Waiting and Loading Restriction) Order 2000 so that:

- (a) waiting restrictions would be revoked in that length of Waddon Road, the east to west arm, the south-east side, between a point opposite the south-western kerb-line of Rigby Close and a point 2 metres north-east of a point opposite the party wall of Nos. 110 and 112 Waddon Road;
- (b) waiting by vehicles would be prohibited:

- (i) at any time throughout the week in those lengths of streets specified in Schedule 1 to this Notice;
- (ii) between 8 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive in that length of Rigby Close, the south-west side, from its junction with Waddon Road north-westward for a distance of 9 metres;
