(a) provide a new pelican crossing on Fulbourne Road at the location specified in Schedule 3 to this Notice. As part of the crossing, zig-zag markings would be laid on both sides of the carriageway on either side of the crossing to prohibit all vehicles from stopping on the markings for any reason; and

(b) extend the existing zig-zag markings on Fulbourne Road outside No. 125 Fulbourne Road to the common boundary of Nos. 127 and 129 Fulbourne Road.

- 4. FURTHER NOTICE IS HEREBY GIVEN that the Council propose to construct entry treatments to control the speed of vehicles, under sections 90G to 90I of the Highways Act 1980 and in accordance with the provisions of the Highways (Traffic Calming) Regulations 1999. The raised entry treatments for vehicles would be constructed in MacDonald Road and Victoria Road at their junctions with Fulbourne Road, level with the adjacent kerbs and would cover the full width of the junction. The existing road hump approximately 14 metres south-west of its junction with Fulbourne Road would be removed.
- 5. **FURTHER NOTICE IS HEREBY GIVEN** that the Council propose to:
- (a) remove the existing footway parking bay adjacent to Siddeley Road;
- (b) remove 5 metres of the existing footway parking outside Nos. 8 and 10 Fulbourne Road;

- (d) extend the existing partial footway parking place outside No. 219 Fulbourne Road.
