##### **THE BEXLEY (FREE PARKING PLACES) (DISABLED PERSONS)(AMENDMENT NO. 2) TRAFFIC ORDER 2013**

NOTICE IS HEREBY GIVEN that the Council of the London Borough on 28th May 2013 have made the above mentioned Order under sections 6, and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended by Section 8 of and Part 1 of Schedule 5 to the Local Government Act 1985.

1. The general effect of the Bexley (Free Parking Places) (Disabled Persons)(Amendment No. 2) Traffic Order 2013 would be to:

(a) designate new disabled parking places in which disabled person's vehicles, displaying a disabled person's blue badge may be left during the permitted hours, without charge, in the vicinity of 27a Horsham Road, Bexleyheath

2. ##### **THE BEXLEY (MISCELLANEOUS PARKING PLACES ORDER) (AMENDMENT NO. XX) TRAFFIC ORDER 2013.**

1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Bexley propose to make the above mentioned Orders under sections 6, and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended by Section 8 of and Part 1 of Schedule 5 to the Local Government Act 1985, and all other enabling powers.

2. The general affect of the Bexley (Waiting and Loading Restriction) ( Amendment No. xx) Traffic Order 2013 would be to amend the extents of single yellow line (no waiting Monday to Friday 8 am to 6.30 pm) and replace it with double yellow lines (no waiting at any time) in the vicinity of Chieveley Parade, Mayplace Road East.

3. The general affect of the Bexley ( Miscellaneous Parking Places Order) ( Amendment No. xx) Traffic Order 2013 would be to amend the extents and location of a parking place which operates 8am to 6.30 pm Monday to Saturday. It is currently at the western end of Chieveley Parade , and is proposed to become 2 parking places at the eastern end of the parade.

4. A bus stop clearway is also relocated in conjunction with these proposals, however this does not require a Traffic Management Order, so whilst your views on this are sought it is not part of the formal TMO process.

5. Copies of the proposed Orders mentioned at the head of this notice, the Orders they amend and any other amendments, the Council's statement of reasons for proposing to make the Orders and a plan indicating the length of road to which the Orders relate can be inspected during normal office hours on Mondays to Fridays inclusive, at the Contact Centre, Civic Offices, Broadway, Bexleyheath, Kent DA6 7LB.
