Turin, March 30.

HIS Court has receiv'd Accounts by two Expresses, of an Attempt made upon the Town of Savona by a Body of French Troops sent from Genoa, but the Governor made such Dispositions as obliged the Enemy to retire, after several fruitless Endeavours to force the advanced Posts. Besides the Body transported by Sea in 200 Row Boats, there was another, which came by Land to secure the Passes and the upper Part of the Mountains. This Court is extremely pleased with the Affistance Vice-Admiral Byng gave in this Affair, who cannonaded the Enemy in their Ports.

Dresden, April 7. That Part of the Russian Army which have passed Miedzyrees have halted to wait for the rest of that Column to come up with them; the most advanced Part of the Russian Army was near Lublin the 1st of this Month. Some Officers who have seen the Russian Troops in Poland, say, they are the finest Body of Men that they ever saw, all young and well made; that they continue to observe the exactest Discipline and Payment, and give the greatest Satisfaction to the Poles.

Hellinrouck near Ruremond, April 11, N, S. His Royal Highness the Duke of Cumberland arrived here Yesterday Noon, when General Ligonier was passing the Meuse with 18 Battalions and 18 Squadrons of his Britannick Majesty's Electoral Troops; and this Morning Lieutenant General Montigni marched into Camp with four Battalions and eight Squadrons more of the said Troops. Count Chancles is retired to within two Leagues of this Place, and Maestricht is invested by Marshal Saxe's Army, while M. Lowendahl remains encamped upon the Eminences from Verviers to Berg, in order to cover the Upper Meuse on that Side, that all their Convoys may come down with Safety, and that he may come into the Plain of Maestricht in Case the Allies should make any Attempt on that Side. The Austrian Corps will march Tomorrow Morning in order to join the Troops here, and leave Major General Puebla with two Austrian Battalions, and two of Pandours, with 500 Austrian Cavalry at Mazeyk, which is a pretty strong Post. General Baroniai is a little advanced before Mazeyk with two Regiments of Hussars, with Orders to patroll forward to the Geul, near to the Enemy's Line of Circumval-Three other Regiments of Hustars dation. are kept on the other Side of the Meuse, to patroll-up towards Rechem, where the Enemy's Line of Circumvallation begins, and to watch

the Motions-of M. d'Etrees, who is detached with a Flying Camp of about 15000 Men, mostly Cavalry, near Brey, and is continually marching and countermarching. To-morrow five Battalions, the last Division of his Britannick Majesty's Electoral Troops, will come into-Camp, and it is expected that Lord Albemarle will arrive the 18th with nine British and four Imperial Battalions, which marched out of Breda Yesterday. General Chanclos has left 12 Battalions and fix Companies of Grenadiers of Imperial Troops, under the Command of Lieutenant General Marechal, and Major General Prince d'Aremberg, with 400 Imperial Horse and 100 Hussars under the Command of Lieutenant Colonel Count Sollern, for the Defence of Maestricht, and had got into that Place, the Day before it was invested, the great Convoy of Powder.

Hague, April 12, N.S. The young Prince was christened Yesterday by the Name of William, with great Solemnity. M. Kalkoen was appointed the Day before Yesterday their High Mightinesses Minister Plenipotentiary to the Court of Dresden. By Letters from Paris there is Advice, that the French King and the Dauphin purpose to be with the Army by the latter End of this Month; and that M. de Sotto Majore, the Spanish Plenipotentiary to the Conferences of Aix la Chapelle, has postponed his Departure from Paris for a few Days. We hear from Zealand, that Vice Admiral Wiltschut, who commanded the Dutch Fleet in those Seas, died there a few Days ago.

Hague, April 16, N.S. The Council of War, which was appointed to revise the Trial of Lieutenant General La Roque, has made an End of that Affair; but wait for the Prince of Orange's Approbation, before they pronounce his Sentence. The Trial of General Cronftrom is to come on next; and he will be ordered to repair to the Hague, as soon as another Person is appointed to command at Bois-le-duc in his Room. Lieutenant General Constant is said to be fix'd upon by the Prince of Orange for that Purpose. M. Kleseker, and M. Meynertzhaven are arrived here; the first as Resident from the Town of Hambourg, the other as Resident from the Margrave of Anspach.
