der named in the Commission, all of them robed in the compleat Habits, and with the Ensigns, met in the Great Chamber in the Dean's Lodgings, to which Place the Dukes of Leeds and Bedford, and the Right Honourable the Earl Granville came in the under Habits, carrying in their Hands their Caps with the Feathers and Hern-Tops fixed thereto.

The Poor Knights and Prebends in their Mantles, attended in the Cloyster, and the Officers of Arms in the Dean's Hall, till the Procession for the Installation began to the Chapter House in the following Manner, the Proctors being first conducted to the Chairs

prepared for them behind the Altar.

Poor Knights two and two; Prebends two and two; Officers of Arms two and two; Earl Granville in the under Habits abovementioned; the Dukes of Bedford and Leeds in Breast in the under Habits; then the Officers of the Order, the Register having on his Right Hand Garter King of Arms, carrying the Sovereign's Commission, and on his Lest the Gentleman Usher of the Black Rod, wearing their Crimson Mantles and Badges of their respective Orders; then the three Commissioners, the Junior first,

Duke of Portland, Duke of Marlborough, Duke of Richmond.

Having thus entred into the North Isle of the Chapel, the Alms Knights, Prebends and Officers of Arms, made a Stand in their proper Distances beyond the Door of the Chapter House, and the three Knights Elect retired to the Chairs placed for them behind the Altar, while the Officers of the Order went into the

Chapter House, where the three Knights Commissioners seated themselves according to their Seniority and Form of Stalls in the Chapel.

Then Garter with Reverence presented the Commission to his Grace the Duke of Richmond, the Senior Companion and Commissioner present, who gave it to the Register; which being read by him and presented to the Knights Commissioners, they re-delivered it to him to be entred. Garter was first commanded to conduct the Earl of Inchiquin, Proctor for Prince George, to the Chapter House Door, where he was received by the two junior Commissioners, and seated on that Side of the Table according to his Principal's Stall in the Chapel.

Garter was then commanded to conduct Sir Clement Cottrell Dormer Proctor for the Duke of Saxe-Gotha, Sir Everard Fawkener Proctor for the Margrave of Anspach, and Sir Robert Wilmot Proctor for Prince Frederick of Hesse, who were all severally seated at the Table according to their Principal's Stall in the Chapel.

Garter was then commanded to conduct the Duke of Leeds to the Chapter-House Door, where he was received by the same two Junior Commissioners, and brought between them to that Part of the Table where his Ensigns were placed, and his Grace was invested with the Surcoat of the Order by the two Senior Commissioners, the Register reading the Admonition, and then the Belt and Sword were buckled on.

Garter was then commanded to conduct the Duke of Bedford to the Chapter-House Door, where being received by the same two Commissioners, was brought in and invested in like Manner as the Duke of Leeds had been before.

Garter was then commanded to conduct Sit Charles Eggleton, Proctor for the Earl of Albemarle, who was seated at the Table according to his Principal's Stall in the Chapel.

After which Earl Granville was introduced and invested in like Manner as the Dukes of

Leeds and Bedford.

The Knights Elect and Proctors remained in the Chapter House, while a Procession was made into the Chapel to offer the Hatchments of the Dukes of Somerset, and Argyll, Earl Poulet, the Duke of Montagu, Sir Robert Walpole Earl of Orford, Earl of Wilmington and Earl of Essex, the late deceased Knights, in the sollowing Manner:

The Poor Knights entred the Chapel Two and Two, and being come into the Middle of the Choir, made their Reverences altogether, first to the Altar, then to the Sovereign's Stall, and proceeded up near to the Rails of the Altar, where they placed themselves on either Side

of it.

The Prebends entred in the same Manner, and stood all of them below the Poor Knights, excepting Two, who were conducted to the Alter to receive the Hatchments to be offered.

The Officers of Arms entred in like Manner, and stood below the Prebends on both Sides.

Then the three Knights Commissioners,

The Duke of Portland, The Duke of Marlborough, The Duke of Richmond,

The Junior entring first, and making his Reverences in the Middle of the Choir to the Altar, and then to the Sovereign's Stall, retired and stood in the Area under his Banner; which Ceremonies were repeated by the other Commissioners singly, and then the Banners, Swords and Helmets of all the deceased Knights, were offered with the usual Ceremonies by these Commissioners.

Which being performed, the Commissioners retired under their respective Banners, and after due Reverences made, the Return to the Chapter-House was in the Manner specified above, and from thence a Procession was made into the Choir in the same Manner, save that Garter being, in the Middle between the Register and the Black, Rod, carried on a Velvet Crimson Cushion, edg'd and tassel'd with Gold, the Mantle, and Book of Statutes, to the Desk of the Seat below the third Stall on the Sovereign's

Side, affigned for Prince George.

The two Senior Commissioners having conducted the Proctor for Prince George to the Seat under the Stall of his Principal, where he was sworn to the Observation of the Statutes, carried him into the Stall; where they put the Mantle over his left Arm, so that the Cross embroidered with the Garter, might be seen, and then they seated him in the Stall, who arising made his Reverences; and these Knights having enabraced him, and congratulated him, in the Name of his Principal, retired under their Banners; and the Proctor, during the remaining Part of the Ceremony, held the Mantle in the Form specified.

In like manner were the Proctors of the Duke of Saxe-Gotha, the Margrave of Anspach, and Prince Frederick of Hesse, conducted and seated, viz. the Proctor for the Duke of Saxe-Gotha in the third Stall on the Prince's Side, the Proctor for the Margrave of Anspach in the fourth Stall on the Sovereign's Side, and the Proctor for Prince Frederick of Hesse in the fourth Stall on

the Prince's Side.

A Return was then made from the Chapel to. the Chapter-House, as usual, and from thence a Procession into the Choir in the same Manner, save that, besides the Mantle and Book of Statutes, Garter carried on the Crimson Velvet Cushion, the Hood, Great Collar, and George appendant thereto, to the Deik of the Seat be low the twelfth Stall on the Sovereign's Side, assigned for the Duke of Leeds. Then the junior Commissioner angly, the Duke of Leeds between the Dukes of Richmond and Mailborough, (the femior Commissioners) who conducted the Knight Elect into the Seat where the Cushion and Ensigns of the Order were placed; there the Knight Elect, laying his Hand on the New Testament, took the Oath for the Observation of the Statutes.

Which being done there, the said two Commissioners conducted him into his Stall, where he was by them invested with the Mantle, Hood, Great Collar, and George, the Register reading the accustomed Admonitions, and the Commissioners delivering to him the Book of Statutes, placed the Cap on his Head, and seated him in his Stall; who presently using, and making his Reverences to the Altar and Sovereign's Stall, the Commissioners embraced and congratulated

him, and, leaving him in his Stall, descended into the Area, and stood under their Banners.

Then the Poor Knights, Prebends, and Officers of Arms, returned towards the Chapter-House, and the Officers of the Ofder and the Commissioners entred into it; from whence the Duke of Bedford was conducted in like Manner, invested and installed in the twelfth Stall on the Prince's Side, by the two senior Commissioners.

Then the Proctor of the Earl of Albemarle was conducted and feated in the thirteenth Stall on the Sovereign's Side, in the same Manner as

the other Proctors beforementioned.

And, lastly, Earl Granville was conducted in like Manner as the Dukes of Leeds and Bed, ford, invested and installed in the thirteenth Stall on the Prince's Side, by the said two Commissioners.

These Installations being finished, and all the Companions in their Stalls, and the Officers of the Order being returned to their Seats, Diving Service was begun, and the Offertory Sentence being read, the Poor Knights made their Roverences, and ranged themselves on both Sides. as near as they could to the Rails of the Altary The Officers of Arms did the same; and Garter rising from his Seat, made his Reverences inthe Middle of the Choir, and summoned East Granville and the Proctor for the Earl of Albemaile, who, having made their Revetences in their Stalls, descended together into the Choir where meeting and repeating the fame, retired under their Banners. Then all the other Kaights and Proctors being summoned, descended and retired in like Manner. All the Knights and Proctors thus standing under their Banners, the two Provincial Kings of Arms repaired to the Proctor of Prince George and to the Proctor of the Duke of Saxe Gotha, who jointly made their Reverences, first upon their moving from under their Banners, and again at the first Steps of the Altar, and being come to the Rails thereof, made their Reverences to the Altar only, and kneeling down offered Gold and Silver, and' rising up, and making their Reverences as before, went into their respective Stalls and sat down. The like was performed by the Proctors of the Margrave of Anspach and Prince Frederick of Hesse. Then the Dukes of Richmond, Marlborough, and Portland, offered fingly: Afterwards the Dukes of Leeds and Bedford together. being Companions: And lastly the Proctor for Lord Albemarle, and Earl Granville, together.

The Knights being all in their Stalls, continued therein 'till Divine Service was ended, and were then summoned to descend into the Area under their respective Banners; and a Procession was made out of the Choir down to the West Gate of the Chapel, and up thro' the South Isle, and out at the South Door, (where the several Proctors lest the Mantles, and went no surther in the Procession) and thence to the Lodgings, the Drums and Trumpets going before; In which Place first went the Poor Knights, the Prebends, next the Officers of Arms, the Officers of the Order, then

Waptes, July z. The rich Diamonds which the King has lately fent as an Present to the Durches of Savoy his Sister, are valued as 40,000 Crowns. On the 9th Instant the whole Court is expected here from Portici, in order to affilt at the Fair which begins the Day after. Rome, July 4. The Marquess de Hopital, Amhassador from his most Christian Majesty to the King of the Two Sicilies, arrived here on Tuesday last from the Tour he has taken to the principal Cities of Italy. The next Day he was presented to the Pope by the Duke de Nivernois, and on the 2d Instant set out for Frascati, from whence he will continue his Journey for Naples. - The Duke de Cesarini, his Sicilian Majesty's new Ambassador to this Court, arrived here two Days ago, and has taken up his Residence at the Farnese Palace.

Warfaw, July 10. The Prince Royal's Regiment of Foot is-ordered to march to Dantzick, to be placed there as a Guard to their Polish Majesties during their Stay in that City., The Court has received certain Advice that the Dietines of Dobrzyn, Cracovia, Sendomir, Ha-Istz, Wilda, Smolensko, Starodub, Ozmian, Lida, Wolkomirz, Trocko, Cauen and Upitz in Lithuania, have all succeeded in their Election of Deputies to the extraordinary Diet; as have Exemile those of Novogorod and Livonia. The Celebration of the Nuptials of Count de Mnizeck, Marshal of the Court, with Mademoiselle de Bruhl, is fix'd for the 14th Instant. (Fienna, July 11. On Wednesday last their Imperial Majesties, accompanied by Prince Charles of Lorrain, came back to Schonbrun from Petau, extremely well fatisfied with the Behaviour and Appearance of the Troops incamped there. General Count de Melligny, Governor of Hermanstadt in Transilvania, and Colonel of a Regiment of Foot, died here a few Days ago.

Berlin, July 18., On the 16th Instant the King came hither from Potzdam, accompanied by Prince Ferdinand of Brunswick, and was soon after followed by the Princes Henry and Ferdinand his Majesty's Brothers, and by divers Lords, of the Court, and General Officers. Soon after his Majesty's Arrival, Sir Hanbury Williams, his Britannick Majesty's Minister Plenipotentiary to this Court, had his first private Audience, and delivered his Credential Letters; the same Day he was admitted to an Audience of the Queen; and the next Day to that of the Queen-Mother. The Baron de Thun, Minister from the Duke of Saxe Gotha was likewise admitted to his Audiences; and Yesterday his Majesty returned to Potzdam.

Manheim, July 18. The Elector Palatine, who was extremely ill all last Week, is now

perfectly recovered.

Hague, July 23. His Serene Highness the Prince of Orange having lately appointed M. de la Sarraz to be Lieutenant Colonel and Captain of the Regiment of Foot of du Verger; Count Alexander de Wertensleben to be Titular Major of the third Battallion of Nassau Orange; and M. Akkersdyk to be Captain to the Regiment of Major General Deutz, they have all taken the usual Oaths before the Council of State for their several Employments. Yesterday the States of Holland and Westfrizeland opened their Assembly.
