

Stoke Lyne, Stratton Audley, Upper Heyford, Wendlebury, and Weston-on-the-Green in the Rural District of Ploughley;

2. To vary the provisions of paragraph (c) of sub-section (3) of section 117 of the local Act so as to enable the Council of the Rural District of Aylesbury alternatively to levy the special rate authorised thereby on some of the parishes or parts of parishes of the Rural District comprised within the limits of the Board for the supply of water as now existing or as may be extended instead of on all the parishes of the District so comprised;

3. To empower the Board to demand water rates half-yearly;

4. To make provision for the exclusive right to the Board in the matter of the connection of any communication pipe with the Board's main;

5. To make provision as to the period of error in defective meters;

6. To empower the Board to prohibit temporarily the use of hosepipes;

7. For the several purposes of the Board's application or for purposes connected with, incidental to, or consequent on those purposes to make any such alteration or amendment of the local Act as may be necessary or desirable;

And whereas the Chiltern Hills Spring Water Company (hereinafter called the Company) have made application to the Minister of Health for the issue of a Provisional Order under the Gas and Water Works Facilities Act, 1870, and the Gas and Water Works Facilities Act, 1870, Amendment Act, 1873, so as:—

To modify the limits within which the Company may supply water by the exclusion therefrom of the following briefly described areas (which are distinguished on Map No. 2 referred to below), that is to say:

The parishes of Westcott, Wotton Underwood and parts of the parishes of Fleet Marston, Hardwicke, Quarrendon, Stone, Waddesdon, and Wendover, in the Rural District of Aylesbury; And whereas the Minister of Health has directed that a joint local Inquiry shall be held into the subject-matters of the applications and the proposed Provisional Orders;

Notice is hereby given that G. S. Wells, Esquire, M.C., M.Inst.C.E., one of the Inspectors of the Ministry of Health, will attend at the County Hall, Aylesbury, on Wednesday the 27th day of January, 1943, at 10 o'clock in the forenoon, to hold the said joint local Inquiry;
